1 A RESOLUTION

2 To commend United States Secret Service Special Agent In Charge Leslie Camille Pichon
3 for her service on the occasion of her promotion.

4 WHEREAS, Special Agent In Charge Pichon is a twenty-three-year veteran of the
5 United States Secret Service and has held supervisory roles in the Presidential Protection
6 Divisions of the administrations of President Barack Obama and President Donald Trump;
7 she also served in the Inspection Division and the Office of Professional Responsibility; and

8 WHEREAS, Special Agent In Charge Pichon has served as Special Agent In Charge
9 of the New Orleans Field Office since July 2018; in this role, she has supervised all Secret
10 Service operations in Louisiana; and

11 WHEREAS, additionally, Special Agent In Charge Pichon worked with the
12 Louisiana State Police as the federal executive sponsor to create the nation's first cyber law
13 enforcement investigative alliance, which works to prevent imminent disruption from cyber
14 threats, and mobilized resources for an active criminal investigation to urgently and
15 thoroughly prevent and remediate a statewide cyber attack in 2020; and

16 WHEREAS, Special Agent In Charge Pichon highlighted the cybersecurity
17 capabilities and achievements of the Louisiana National Guard; her praise led not only to the
18 Louisiana National Guard receiving national recognition, but also to its selection to lead a
19 pilot program for cyber forensics training; and

20 WHEREAS, Special Agent In Charge Pichon is a Slidell, Louisiana, native and
21 graduate of Louisiana State University; she has successfully leveraged her intellectual

1 capabilities and love of Louisiana to improve the state through her implementation of
2 innovative cybersecurity strategies; she is most deserving of the highest recognition.

3 THEREFORE, BE IT RESOLVED that the House of Representatives of the
4 Legislature of Louisiana does hereby commend United States Secret Service Special Agent
5 In Charge Leslie Camille Pichon for her service on the occasion of her promotion; does
6 hereby further recognize her contributions to the government and taxpayers of Louisiana in
7 the areas of cybersecurity and interoperability in cyber law enforcement; and does hereby
8 extend sincerest well wishes as she advances her career after accepting an internal promotion
9 in Washington, D.C.
