1	AN ACT
2	To amend and reenact R.S. 36:254(A)(14) and R.S. 39:98.3(B)(2) and 98.4(B)(3)(a), and to
3	repeal R.S. 17:1519.12 and 2048.51(C)(14) and (N), and Chapter 21 of Title 17 of
4	the Louisiana Revised Statutes of 1950, comprised of R.S. 17:3051 through 3060,
5	and R.S. 36:259(B)(22) and 651(C)(8), relative to boards, commissions, authorities,
6	districts, and like entities and the powers, functions, duties, responsibilities, and
7	jurisdictions thereof; to provide relative to the functional organization of state
8	government by abolishing certain boards, commissions, authorities, districts, and like
9	entities; to provide for any necessary transitions and transfers; to remove references
10	to certain abolished entities; to remove references to, provisions for, and the powers,
11	functions, and duties of the Medical Education Commission; to remove references
12	to, provisions for, and the powers, functions, and duties of the Health Education
13	Authority of Louisiana and its board; to provide relative to the assets of the Health
14	Education Authority of Louisiana; and to provide for related matters.
15	Be it enacted by the Legislature of Louisiana:
16	Section 1. The legislature finds that abolishing, transferring, and consolidating
17	certain boards, commissions, and other statutorily created entities is in the public interest
18	when such entities no longer serve a public purpose. It is the intent of the legislature to
19	abolish, transfer, and consolidate boards, commissions, and other statutorily created entities
20	and make other changes as provided in this Act.

22	Section 2. (A) R.S. 36:254(A)(14) is hereby amended and reenacted to read as
23	follows:
24	§254. Powers and duties of the secretary of the Louisiana Department of Health
25	A. In addition to the functions, powers, and duties otherwise vested in the
26	secretary by law, he shall:

2	(14) Determine how funding for residency positions, residency supervision,
3	and other medical education resources shall be allocated among institutions which
4	provide medical education at hospitals in the health care services division of the
5	Louisiana State University Health Sciences Center, including the Medical Center of
6	Louisiana at New Orleans, to ensure that there is an equitable distribution among
7	medical education programs providing services in public institutions. In making such
8	determinations, the secretary shall consider advice provided by the Medical
9	Education Commission, the historical distribution of graduate medical education
10	resources, the long-term effects of the allocation of medical education resources to
11	each program, and the clinical workload of each program.

13	(B) R.S. 39:98.3(B)(2) and 98.4(B)(3)(a) are hereby amended and reenacted to read
14	as follows:
15	§98.3. Appropriations from the Health Excellence Fund, the Education Excellence
16	Fund, and the TOPS Fund

18	B. Appropriations from the Health Excellence Fund shall be restricted to the
19	following purposes:
20	* * *
21	(2) A program of research grants and projects that encourage the pursuit of
22	innovation in advanced health care sciences; such program shall support clinical and
23	laboratory research efforts based in Louisiana universities, as well as institutions
24	represented in the membership of the Medical Education Commission as provided
25	in R.S. 17:1519.8, and shall fund grants for both basic and applied research in
26	advanced health care sciences; such program shall encourage institutional
27	commitment and leveraging of state monies to secure private and federal funds and
28	shall be administered by the Board of Regents through an objective, competitive
29	process subject to peer review. The Board of Regents shall annually submit to the
30	legislature and the governor, not less than forty-five days prior to the beginning of

6	B. Appropriations from the Fund shall be restricted to the following purposes
7	provided in this Subsection, and no annual appropriation for any one of the purposes
8	enumerated in Paragraphs (1) through (4) of this Subsection may exceed fifty percent
9	of the total amount of monies appropriated from the Fund in any fiscal year:

11	(3) Initiatives to benefit the citizens of Louisiana with respect to health care
12	through:

16	represented in the membership of the Medical Education Commission as provided

27	repealed.

29	Section 3.(A) Chapter 21 of Title 17 of the Louisiana Revised Statutes of 1950,
30	comprised of R.S. 17:3051 through 3060, is hereby repealed in its entirety.

1	(B) R.S. $36:651(C)(8)$ is hereby repealed in its entirety.
2	(C) The commissioner of administration is hereby authorized to enter into such
3	documents, contracts, agreements, covenants, conditions, stipulations, or other instruments
4	and to execute such documents as necessary to properly effectuate any conveyance, transfer,
5	assignment, lease, or delivery of title to any immovable property of Health Education
6	Authority of Louisiana to the state of Louisiana. Any funds on deposit in the name of Health
7	Education Authority of Louisiana not transferred to another entity or official shall be the
8	property of the state and the state treasurer shall provide for the deposit of such funds in the
9	state treasury to the credit of the state general fund, after deposit in the Bond Security and
10	Redemption Fund as otherwise provided by law.
11	Section 4. This Act shall become effective upon signature by the governor or, if not
12	signed by the governor, upon expiration of the time for bills to become law without signature
13	by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If
14	vetoed by the governor and subsequently approved by the legislature, this Act shall become
15	effective on the day following such approval.
