1	AN ACT
2	To amend and reenact R.S. 37:1042(A), (B), the introductory paragraph of (C)(1), and (D),
3	1045(A), and 1049(1) and to repeal R.S. 37:1055 and 1060, relative to the Louisiana
4	State Board of Optometry Examiners; to provide for board membership; to provide
5	for a nomination process; to provide for term limits; to provide for board members
6	who are also members in an optometrist trade association; to provide for a quorum
7	of the board; to provide for qualifications and requirements of applicants for
8	licensure by the board; to repeal laws relative to recording of certain certificates and
9	issuance of lists of licensed optometrists; to provide for an effective date; and to
10	provide for related matters.
11	Be it enacted by the Legislature of Louisiana:
12	Section 1. R.S. 37:1042(A), (B), the introductory paragraph of (C)(1), and (D),
13	1045(A), and 1049(1) are hereby amended and reenacted to read as follows:
14	§1042. Louisiana State Board of Optometry Examiners; appointment; terms of
15	members; protected action and communication
16	A. The Louisiana State Board of Optometry Examiners is created within the
17	Louisiana Department of Health and is subject to the provisions of R.S. 36:803. This
18	The board shall consist of five members who shall be are actively licensed
19	optometrists in good standing with the board and shall who have practiced
20	optometry in this state for seven years and one consumer member.
21	B.(1) Each One licensed optometrist member of the board shall be appointed
22	by the governor from a list of three names submitted to him by the board from each

1	of the five board districts in accordance with this Subsection. The governor shall
2	ensure that his appointments demonstrate race, gender, ethnic, and geographical
3	diversity. For the purpose of preparing the list of three names, the board shall
4	conduct an annual meeting on a date in June set by the board annually, at which all
5	optometrists licensed under the laws of Louisiana shall have the right to attend,
6	nominate and vote. The board shall have the authority to regulate and prescribe the
7	place and hour of the meeting, the method of nomination, and the manner of voting.
8	Each optometrist in attendance shall have the right to vote for those persons duly
9	nominated and no cumulative or proxy voting shall be permitted. Each optometrist
10	voting must vote for three nominees in order for his ballot to be valid, and any ballot
11	indicating votes for more or less than three nominees shall be null and void. The
12	three persons receiving the greatest number of votes of those in attendance at the
13	meeting shall be the three persons whose names shall be submitted to the governor
14	for appointment to the board. At least thirty days prior to the meeting the board shall
15	mail notices to each optometrist licensed under the laws of Louisiana at the address
16	shown in his current registration notifying each optometrist of the exact date, place
17	and hour of the meeting, the purpose of the meeting and of his right to attend and
18	vote. The consumer member may apply directly to the office of the governor.
19	(2) The board districts shall be comprised of the following parishes:
20	(a) District One shall be comprised of the parishes of Jefferson, Orleans,
21	<u>Plaquemines, St. Bernard, St. Charles, St. Helena, St. Tammany, Tangipahoa,</u>
22	and Washington.
23	(b) District Two shall be comprised of the parishes of Ascension,

3	(e) District Five shall be comprised of the parishes of Bienville, Bossier,
4	<u>Caddo, Caldwell, Claiborne, DeSoto, East Carroll, Franklin, Jackson, Lincoln,</u>

1	failure to act, the duties of the secretary with respect to the mailing and
2	counting of ballots and the certification to the governor shall be performed by
3	the president of the board.
4	(5) The successor to each member of the board appointed from a board
5	district shall be appointed from the district having the same number
6	designation as the district from which the member who is being replaced was
7	appointed.
8	(6) District representatives shall be initially appointed as follows:
9	(a) A representative from District Four to fill a vacancy in the position
10	expiring in June 2022.
11	(b) A representative from District One to fill a vacancy in the position
12	expiring in June 2023.
13	(c) A representative from District Five to fill a vacancy in the position
14	expiring in June 2024.
15	(d) A representative from District Three to fill a vacancy in the position
16	<u>expiring in June 2025.</u>
17	(e) A representative from District Two to fill a vacancy in a position
18	<u>expiring in June 2026.</u>
19	C.(1) The consumer member shall be selected from the state at large and
20	appointed by the governor. Any person interested in serving as the consumer
21	member may apply directly to the office of the governor. The consumer member
22	of the board shall possess all of the following qualifications:

24	D.(1) Each appointment by the governor shall be subject to Senate
25	confirmation. The term of each member shall be five years, except that no person
26	shall be appointed to serve more than three full terms on the board, whether the
27	service is consecutive or not. but vacancies A vacancy occurring during the term
28	of a member shall be filled for the unexpired term by an optometrist possessing the
29	qualifications for board membership, nominated by the remaining members of the
30	board and appointed in accordance with Subsection B of this Section. and

1	appointed by the governor from that nomination. A vacancy in the consumer position
2	shall be filled with another consumer.
3	(2) No member of the board shall hold an elected or appointed position
4	in an optometry professional association at any time during the term of his
5	appointment to the board. The provisions of this Paragraph shall not be
6	construed to prohibit a member of the board from holding an elected or
7	appointed position in an association for regulatory boards of optometry.

9	§1045. Officers; meetings; quorum
10	A. The board shall choose from its membership a president and a
11	secretary-treasurer. The board shall hold regular semiannual meetings. Three <u>Four</u>
12	members shall constitute a quorum for the transaction of business.
13	* * *
14	§1049. Qualifications and requirements of applicants
15	All persons desiring to become licensed to practice optometry shall:
16	(1) Be citizens of the United States; or possess valid and current legal
17	authority to reside and work in the United States duly issued by the Citizenship
18	and Immigration Services agency of the United States Department of Homeland
19	Security, and be of good moral character.
20	* * *
21	Section 2. R.S. 37:1055 and 1060 are hereby repealed.
22	Section 3.(A) The provision of this Act prohibiting a member of the Louisiana State
23	Board of Optometry Examiners from serving more than three full terms on the board shall
24	only apply to any term that began on or after January 1, 2016. The provisions of this Act
25	shall not prohibit any current board members who have served more than three full terms
26	from continuing to serve in that position for the remainder of their term or until a successor
27	is appointed.
28	(B) No provision of this Act shall be construed to prohibit a board member whose
29	term expires in June of 2022 from continuing to serve in that position until a successor is
30	appointed in accordance with the provisions of this Act.

1	Section 4. This Act shall become effective upon signature by the governor or, if not
2	signed by the governor, upon expiration of the time for bills to become law without signature
3	by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If
4	vetoed by the governor and subsequently approved by the legislature, this Act shall become
5	effective on the day following such approval.
