1 AN ACT

2 To amend and reenact R.S. 26:274(A)(2) and 308(C)(8), relative to alcohol beverage  
3 control; to provide relative to permits for dealers in beverages of low alcohol  
4 content; to provide relative to local permits; to provide for exceptions for delivery;  
5 and to provide for related matters.

6 Be it enacted by the Legislature of Louisiana:

7 Section 1. R.S. 26:274(A)(2) and 308(C)(8) are hereby amended and reenacted to  
8 read as follows:

9 §274. Local permits

10 A.(1) Parishes and municipalities may issue and require local permits similar  
11 to those issued by the commissioner and may charge and collect fees therefor. No  
12 parish or municipality shall require permits of any commercial airline which has  
13 been issued a Class B retailer permit.

14 (2) Parishes and municipalities may issue and require local permits similar  
15 to those issued by the commissioner for the delivery of alcoholic beverages by  
16 grocery stores, restaurants, and third parties. Parishes and municipalities shall not  
17 require a local permit for any third-party delivery company which has been issued  
18 a state delivery service permit in accordance with the provisions of this Chapter.  
19 Parish and municipalities shall not require an additional local permit for the delivery  
20 of alcoholic beverages by any licensed retail dealer that has been issued a state  
21 delivery service permit in accordance with the provisions of this Chapter.

3                   C. An alcoholic beverage delivery agreement between a retail dealer and a  
4           third party shall require all of the following:

6                   (8)(a) ~~For any parish having a population of less than one hundred thousand~~  
7           ~~according to the latest federal decennial census, no~~ No alcoholic beverages shall be  
8           delivered more than ~~twenty-five~~ twenty miles from the place of purchase.

9                   ~~(b) For any parish having a population of greater than one hundred thousand~~  
10           ~~according to the latest federal decennial census, no~~ alcoholic beverages shall be  
11           delivered more than ten miles from the place of purchase.
