<u>Present law</u> provides for special identification cards such as veteran designation, disabled veteran designation, or autism. <u>Proposed law</u> retains <u>present law</u> and adds "Suicide Lifeline dial 988" to special identification cards.

Proposed law makes technical changes.

Effective upon signature of the governor or lapse of time for gubernatorial action.
