WATER MANAGEMENT. Creates the Louisiana Watershed Initiative. (8/1/23)

1	AN ACT
2	To amend and reenact R.S. 36:4(B)(1)(a), to enact Part VIII of Chapter 2 of Title 49 of the
3	Louisiana Revised Statutes of 1950, to be comprised of R.S. 49:220.41 through
4	220.45, and to repeal R.S. 38:90.2 and 90.5, relative to the Louisiana Watershed
5	Initiative; to provide for purpose; to create the Watershed Management Council
6	within the office of the governor; to require the council to make recommendations;
7	to provide for membership of the council; to provide relative to compensation; to
8	provide for powers, duties, and authority of the council; to provide for regional
9	watershed coalitions; to provide for rules and regulations; to provide for terms and
10	definitions; to provide for public notice; to provide with respect to funding
11	mechanisms and allocations; and to provide for related matters.
12	Be it enacted by the Legislature of Louisiana:
13	Section 1. R.S. 36:4(B)(1)(a) is hereby amended and reenacted to read as follows:
14	§4. Structure of executive branch of state government
15	* * *
16	B. The office of the governor shall be in the executive branch of state
17	government.

1	(1) The following agencies and their powers, duties, functions, and	
2	responsibilities are hereby transferred to the office of the governor:	
3	(a) Division of administration (Subtitle I of Title 39 of the Louisiana Revised	
4	Statutes of 1950 generally, including but not limited to R.S. 39:1 et seq., 11 et seq.

13	Section 2. Part VIII of Chapter 2 of Title 49 of the Louisiana Revised Statutes of	
14	1950, comprised of R.S. 49:220.41 through 220.45, is hereby enacted to read as follows:	
15	PART VIII. LOUISIANA WATERSHED INITIATIVE	
16	<u>§220.41. Louisiana Watershed Initiative; purpose</u>	
17	A. The state of Louisiana recognizes that Louisiana's abundant water	
18	resources can often endanger communities and that water does not follow	
19	political boundaries, but rather responds to geological, bathymetrical, and	
20	hydrological boundaries.	
21	B. The purpose of this Part is to establish the Watershed Management	
22	Council to develop, implement, and manage the Louisiana Watershed Initiative,	
23	a statewide, comprehensive watershed planning process that fosters the	
24	collaborative management of Louisiana's flood risks by local, state, and regional	
25	governmental entities.	
26	C. The legislature hereby finds that:	
27	(1) Louisiana communities are hydraulically and hydrologically	
28	connected within the bounds of a watershed, and decisions made in one portion	
29	of a watershed may impact floodplains in other portions of the same watershed.

1	(2) Flooding after a rain event is not only related to the amount and
2	intensity of rainfall received, but is also closely tied to land use, as well as policy
3	and infrastructure decisions.
4	(3) Floodplains are impacted by actions and decisions made by a wide
5	variety of people, laws, and regulatory bodies, including private landowners,
6	municipalities, parish leaders, zoning laws, building codes, regulations, and
7	federal requirements.
8	(4) Existing practices across varying levels of government do not
9	currently provide for the comprehensive floodplain management that is
10	necessary to properly address drainage issues as land is developed.
11	(5) The increasing frequency and extent of flood events demands
12	heightened levels of coordination, information sharing, and response among
13	state agencies and local and regional stakeholders in order to more closely align
14	resources and programs designed to protect communities from flooding and
15	manage floodplains and watersheds effectively.
16	D. The legislature further finds that cooperative endeavors and
17	coordination amongst local governments, parish governments, and political
18	subdivisions within a watershed region boundary, in furtherance of the goals of
19	the Watershed Initiative as provided in this Part, constitute a public purpose as
20	contemplated by Article VII, Section 14(C) of the Constitution of Louisiana.
21	E. It is the purpose and intent of the legislature, through the creation of
22	the Watershed Management Council to improve the way residents and
23	governments understand, address, and respond to flood risks; to organize a
24	structure for making changes and improvements on a watershed scale; and to
25	develop modeling, planning, and data tools that inform and support more
26	effective watershed-based floodplain management.
27	§220.42. Definitions
28	As used in this Part, the following terms shall have the meanings
29	ascribed to them unless the context clearly indicates otherwise:

1	(1) "Council" means the Watershed Management Council.
2	(2) "Floodplain" means any area of land within a watershed that is
3	susceptible to inundation by floodwaters from any source.
4	(3) "Watershed" means a geographic area within the boundary of a
5	drainage divide that drains all of its streams and rainfall into a common outlet.
6	§220.43. Watershed Management Council; creation; membership
7	A. There is hereby created within the division of administration the
8	Watershed Management Council.
9	B. The council shall be composed of the following members:
10	(1) The commissioner of administration or his designee, who shall serve
11	<u>as chairman.</u>
12	(2) A member appointed by the speaker of the House of Representatives
13	from the membership of the House Committee on Transportation, Highways,
14	and Public Works.
15	(3) A member appointed by the president of the Senate from the
16	membership of the Senate Committee on Transportation, Highways, and Public
17	<u>Works.</u>
18	(4) The secretary of the Department of Transportation and Development
19	<u>or his designee.</u>
20	(5) The chairman of the Coastal Protection and Restoration Authority
21	<u>or his designee.</u>
22	(6) The executive director of the Louisiana office of community
23	development or his designee.
24	(7) The director of the Governor's Office of Homeland Security and
25	Emergency Preparedness or his designee.
26	(8) The secretary of the Department of Wildlife and Fisheries or his
27	designee.
28	(9) The secretary of the Department of Environmental Quality or his
29	designee.

1	(10) The secretary of the Department of Natural Resources or his
2	designee.
3	(11) The commissioner of agriculture and forestry or his designee.
4	(12) A member appointed by the president of the Association of Levee
5	Boards of Louisiana from the membership of the association.
6	(13) The chairman of the State Soil and Water Conservation Commission
7	or his designee.
8	(14) The executive director of the Police Jury Association of Louisiana
9	or his designee.
10	(15) The executive director of the Louisiana Municipal Association or his
11	designee.
12	C. A majority of the members shall constitute a quorum. Members of
13	the council shall not be compensated for their services but may seek travel
14	reimbursement from their respective agencies in accordance with the agency's
15	travel reimbursement guidelines.
16	§220.44. Watershed Management Council; powers and duties; authority
17	A. The Watershed Management Council shall have the following powers
18	and duties:
19	(1) Develop, implement, and manage the Louisiana Watershed Initiative
20	to foster the collaborative management of Louisiana's flood risks by local, state,
21	and regional governmental entities.
22	(2) Promote a unified effort, built on scientific and engineering
23	principles, to address flooding issues across the state.
24	(3) Achieve consistency in project planning and modeling activities
25	across the Louisiana Watershed Initiative.
26	(4) Identify and work with or seek input from additional local, state, and
27	federal agencies, and other stakeholders including but not limited to nonprofit
28	research institutions, university research institutions, drainage or levee boards,
29	and other local districts, and private sector companies.

1	(5) Expand, develop, and use in-state skill, knowledge, technology, and
2	talent to develop and implement the program promoting Louisiana resources
3	through collaboration, communication, and cooperation among governmental,
4	nongovernmental, for-profit, nonprofit, and university entities.
5	(6) Increase state and local resilience to flooding by working to improve
6	response to flooding and reduce the instances, damage, and amount of time
7	needed to recover from flooding.
8	(7) Create a path for the state and its various jurisdictions and political
9	subdivisions to coordinate at a statewide and watershed level plan to maximize
10	flood risk reduction in coordination with the natural and beneficial functions
11	of the watershed and its floodplains, and to consistently manage floodplains
12	using contextually appropriate best practices.
13	(8) Work with the interdependencies of our communities, infrastructure,
14	political jurisdictions, and the natural environment to increase Louisiana's
15	resilience and its ability to adapt and thrive.
16	(9) Promote actions, including legislative, administrative, and regulatory,
17	where appropriate, to enhance watershed and floodplain management in
18	Louisiana.
19	(10) Identify, prioritize, acquire, and establish funding mechanisms to
20	enhance and further efforts associated with the Louisiana Watershed Initiative.
21	(11) Facilitate watershed-based floodplain management by working to
22	create watershed-bounded entities across the state.
23	(12) Develop an approach to watershed-based floodplain management
24	that is recognized as a model for others nationally and internationally.
25	(13) Create, update, review, and revise a statewide watershed plan in a
26	manner that is consistent with applicable federal laws and regulations and with
27	the comprehensive master coastal protection plan as defined by R.S. 49:214.2.
28	(14) Establish and provide assistance to temporary regional steering
29	committees within each watershed region boundary to provide input in the

1	development and implementation of long-term regional watershed		
2	organizational structures, watershed management strategies, and the		
3	implementation of projects, programs, and policies emanating from strategic		
4	<u>efforts.</u>		
5	(15) Employ, appoint, remove, assign, and promote staff necessary for		
6	the efficient administration of this Part, provided that sufficient funds are		
7	specifically appropriated, available through federal grants, or through		
8	interagency transfer agreements.		
9	(16) Approve, upon the recommendation of regional steering committees,		
10	regional watershed coalitions formed among parishes, political subdivisions,		
11	and municipal governments within a designated watershed region to coordinate		
12	the development of watershed management plans and to aid in administering		
13	the implementation of projects, programs, and policies emanating from those		
14	planning efforts. This authority shall be exercised consistent with R.S.		
15	<u>49:220.45.</u>		
16	(17) Allocate funds to regional watershed coalitions, should sufficient		
17	funds become available through either state, federal, or private sources.		
18	(18) Promulgate rules and regulations necessary to implement the		
19	provisions of this Part.		
20	B. Nothing in this Chapter shall interfere with the statutorily-granted		
21	authority of any state agency or local government.		
22	§220.45. Regional watershed coalitions; creation; powers and duties		
23	A. In order to foster regionally led watershed-based floodplain		
24	management, the Watershed Management Council may approve permanent		
25	regional watershed coalitions from the recommendations submitted by regional		
26	steering committees within watershed regions.		
27	B. The council shall consider the approval of regional watershed		
28	coalitions in a manner consistent with the following procedure:		
29	(1) The regional steering committee shall submit a written		

1	recommendation that includes the proposed membership and structure of the
2	regional watershed coalition that provides the most effective framework for a
3	designated watershed to meet the goals and objectives of the Louisiana
4	Watershed Initiative.
5	(2) The council shall hold a public hearing for consideration of the
6	recommendation after publishing a public notice of intention to create a
7	regional watershed coalition three times in the official journal of the state and
8	the official journal of each parish contained within the designated watershed
9	regional boundary. The publications shall be not less than fifteen days prior to
10	the date of the public hearing.
11	(3) Thirty days after holding the public hearing and considering any
12	public comments received, the council may either approve the recommendation
13	to create the regional watershed coalition or return the recommendation to the
14	regional steering committee for further consideration if the council determines
15	either of the following:
16	(a) The recommendation needs to address the public comments received.
17	When considering comments related to the creation of a particular regional
18	watershed coalition, comments from individuals and entities located within the
19	particular watershed region shall be given greater weight than those from
20	outside of the region.
21	(b) The recommendation is inconsistent with the purpose of this Part and
22	with requirements imposed by federal or state funding agreements.
23	(4) The council shall foster collaboration amongst approved regional
24	watershed coalitions by convening meetings to resolve disputes and issuing
25	recommendations for actions that prioritize the goals and objectives of this Part.
26	C. Approved regional watershed coalitions shall constitute a political
27	subdivision of the state of Louisiana and shall be subject to the Open Meetings
28	Law pursuant to R.S. 42:11 et seq., and the Public Records Law pursuant to
29	R.S. 42:1 et seq.

1	D. Regional watershed coalitions may:
2	(1) Develop regional watershed management plans and facilitate regional
3	watershed floodplain management using best practices in consultation with the
4	Watershed Management Council and its member's agencies.
5	(2) Receive funds as authorized by the legislature, the executive branch,
6	the federal government, or through other public or private sources provided
7	that those funds are spent in accordance with the goals and objectives of the
8	statewide watershed plan.
9	(3) Provide technical assistance, development guidance, and support to
10	local entities in watershed management and flood risk reduction.
11	(4) Provide public outreach and education to residents and local leaders
12	to support long-term capacity building on watershed management and flood
13	risk reduction, including technical support of best practices for land use,
14	development, and building codes.
15	(5) Enter into cooperative endeavor agreements with the council to
16	provide organizational and technical support in furtherance of this Part.
17	(6) Facilitate meetings of local entities to support and advance land use
18	and development practices and water management projects that reduce flood
19	risks without causing undue harm to neighboring jurisdictions or regions.
20	(7) Propose, support, and review projects that reduce flood risks without
21	causing undue harm to neighboring jurisdictions or regions.
22	Section 3. R.S. 38:90.2 and 90.5 are hereby repealed.

- (3) A member appointed by the president of the Senate from the membership of the Senate Committee on Transportation, Highways, and Public Works.
- (4) The secretary of the Department of Transportation and Development or his designee.
- (5) The chairman of the Coastal Protection and Restoration Authority or his designee.
- (6) The executive director of the Louisiana office of community development or his designee.
- (7) The director of the Governor's Office of Homeland Security and Emergency Preparedness or his designee.

- (9) The secretary of the Department of Environmental Quality or his designee.
- (10) The secretary of the Department of Natural Resources or his designee.

- (12) A member appointed by the president of the Association of Levee Boards of Louisiana from the membership of the association.
- (13) The chairman of the State Soil and Water Conservation Commission or his designee.
- (14) The executive director of the Police Jury Association of Louisiana or his designee.
- (15) The executive director of the Louisiana Municipal Association or his designee.

<u>Proposed law</u> provides for the powers and duties of the council that include developing, implementing, and managing the Louisiana Watershed Initiative and associated actions that encourage collaboration on an interconnected statewide and watershed basis. <u>Proposed law</u> further authorizes the council to create, update, and revise a statewide watershed plan, establish temporary regional steering committees, approve permanent regional watershed coalitions, allocate funds to these coalitions, and promulgate rules and regulations to implement proposed law.

<u>Proposed law</u> provides that nothing in <u>proposed law</u> shall interfere with the statutorilygranted authority of any state agency or local government.

<u>Proposed law</u> provides for the approval of regional watershed coalitions by the council based upon the recommendation of a regional steering committee, a publicly noticed public hearing, and public comments.

<u>Proposed law</u> provides approved regional watershed coalitions are political subdivisions of the state and are subject to the Open Meetings Law and the Public Records Law.

Proposed law authorizes regional watershed coalitions to develop regional watershed

<u>Present law</u> creates the Floodplain Evaluation and Management Commission to revise the flood information database. <u>Present law</u> provides for the methodology for evaluating flood-control projects. <u>Proposed law</u> repeals present law.

Effective August 1, 2023.

(Amends R.S. 36:4(B)(1)(a); adds R.S. 49:220.41-220.45; repeals R.S. 38:90.2 and 90.5)
