WATER MANAGEMENT. Provides relative to the Acadiana Watershed District. (8/1/23)

1	AN ACT
2	To enact Chapter 17 of Title 38 of the Louisiana Revised Statutes of 1950, to be comprised
3	of R.S. 38:3321 through 3327, relative to the Acadiana Watershed District; to create
4	and provide for the Acadiana Watershed District; to provide for the boundaries and
5	purposes of the district; to create and provide for a board of commissioners of the
6	district; to provide for the composition, powers, and duties of the board, including
7	the authority to levy taxes within the district; to provide relative to the district's
8	relationship with the division of administration, the Department of Transportation
9	and Development, and the Coastal Protection and Restoration Authority; and to
10	provide for related matters.
11	Notice of intention to introduce this Act has been published.
12	Be it enacted by the Legislature of Louisiana:
13	Section 1. Chapter 17 of Title 38 of the Louisiana Revised Statutes of 1950,
14	comprised of R.S. 38:3321 through 3327, is hereby enacted to read as follows:
15	CHAPTER 17. ACADIANA WATERSHED DISTRICT
16	<u>§3321. Creation; boundaries</u>
17	The Acadiana Watershed District, referred to in this Chapter as the

1	"district," is hereby created. The district shall lie within the Atchafalaya,
2	Mermentau, Mermentau Headwaters, Teche, and Vermilion watersheds,
3	situated in the parishes of Acadia, Allen, Avoyelles, Calcasieu, Cameron,
4	Evangeline, Iberia, Iberville, Jefferson Davis, Point Coupee, Rapides, St.
5	Landry, St. Martin, St. Mary, and Vermilion. The district boundaries within
6	those parishes shall be aligned with the geographic area composed of
7	Hydrologic Unit Subbasins 08080101, 08080102, 08080103, 08080201, and
8	08080202, as defined by the United States Geological Survey Watershed
9	Boundary Dataset as of August 1, 2023. The Louisiana Watershed Flood Center,
10	in consultation with the office of state lands and the Coastal Protection and
11	Restoration Authority, shall submit to the legislature a detailed legal description
12	of the Acadiana Watershed District boundaries by January 1, 2024.
13	§3322. Purpose
14	The purpose of the district shall be to:
15	(1) Participate in any activity designed and conducted to promote
16	drainage and flood-risk reduction within the boundaries of the district.
17	(2) Promote and support a unified effort to address drainage and flood
18	issues in the region in cooperation with local, state, and federal agencies.
19	(3) Identify local public sources of revenue or expenditure that may be
20	used to draw down federal matching funds for the provision of drainage
21	projects to reduce flood risk.
22	(4) Cooperate with local, state, and federal entities engaged in planning
23	and construction of drainage and flood reduction and mitigation projects in the
24	state and region.
25	(5) Cooperate with local and state entities engaged in establishing best
26	practice development standards for flood-risk reduction and mitigation in the
27	region.
28	§3323. Corporate status; domicile
29	A. The district shall constitute a body corporate in law and shall be a

1	political subdivision of the state. The district may incur debt and contractual
2	obligations in accordance with law, sue and be sued, purchase and sell property,
3	have a corporate seal, and do and perform any and all acts in its corporate
4	capacity and in its corporate name which are necessary and proper for carrying
5	out the purposes and objects for which it is created.
6	B. The district shall be domiciled and shall establish an office for the
7	transaction of its business operations at a location within the boundaries of the
8	<u>district.</u>
9	C. The district may own, operate, and maintain a regional sensor
10	network to inform water management practices.
11	D. The district shall recognize the Louisiana Watershed Flood Center
12	at the University of Louisiana at Lafayette as a center of excellence for
13	watershed management for the purposes of serving as a community resource
14	and authority on research-based data including but not limited to hydraulic and
15	hydrologic data, watershed models, and innovative watershed practices.
16	E. The district shall be the primary and official repository for all data
17	and models developed for Hydrologic Unit Subbasins 08080101, 08080102,
18	08080103, 08080201, and 08080202 and shall also receive, own, operate, and
19	maintain the Louisiana Watershed Initiative Region 5 hydrologic and hydraulic
20	models and any derivative work therein.
21	F. The district shall be audited pursuant to R.S. 24:513.
22	§3324. Board of commissioners; appointments; terms; vacancies
23	A. The Board of Commissioners of the Acadiana Watershed District,
24	referred to in this Chapter as the "board", is hereby created. The governance,
25	control, and management of the affairs of the district shall be vested in the
26	board.
27	B. The board shall be comprised of the following members:
28	(1) The police jury presidents of the parishes of Acadia, Allen, Avoyelles,
29	Calcasieu, Cameron, Evangeline, Jefferson Davis, Rapides, and Vermilion, or

1	their respective designees.
2	(2) The parish presidents of the parishes of Iberia, Iberville, Pointe
3	Coupee, St. Landry, St. Martin, and St. Mary, or their respective designees.
4	C. The board may appoint a technical advisory committee to advise the
5	board on scientific, engineering, and other technical matters. Committee
6	members shall not have voting rights on the board of commissioners. The
7	committee shall be composed of the following members, who shall be nominated
8	by their respective constituent organizations:
9	(1) A representative of Louisiana Soil & Water Conservation District
10	<u>IV.</u>
11	(2) A representative of the Teche-Vermilion Fresh Water District.
12	(3) A representative of the University of Louisiana at Lafayette
13	Watershed Flood Center.
14	(4) A representative of the Louisiana Natural Resources Conservation
15	Service of the U.S. Department of Agriculture Natural Resources Conservation
16	Division.
17	(5) Two at-large members nominated by a municipality or
18	municipalities with a population of thirty thousand or more and meeting the
19	technical qualification requirements described in this Section.
20	(6) Two at-large members nominated by a municipality or
21	municipalities with a population of less than thirty thousand and meeting the
22	technical qualification requirements described in this Section.
23	(7) One member nominated by the secretary of the Department of
24	Transportation and Development.
25	(8) One member nominated by the executive director of the Coastal
26	Protection and Restoration Authority.
27	(9) One member nominated by the Commander and District Engineer
28	of the New Orleans District, U.S. Army Corps of Engineers.
29	D. All public officials or designees serving on the board shall serve terms

1	concurrent with their term of office. Technical advisory committee members
2	shall serve terms of three years, with the initial terms staggered in accordance
3	with the board's bylaws.
4	E. Members of the board, member designees, and technical advisory
5	committee appointees shall reside within the boundaries of the district or any
6	parish within which a portion of the district lies.
7	F. Board member designees and technical advisory committee
8	appointees shall have professional experience in engineering, project
9	management, certified flood plain management, or other drainage-related field
10	such as geosciences, hydrology, or water management.
11	§3325. Officers; vacancies; compensation
12	A. The commissioners shall elect from their membership a chairman,
13	a vice chairman, and a secretary-treasurer. The duties of the officers shall be
14	fixed by the bylaws adopted by the board.
15	B. Any vacancy which occurs in the membership of the board shall be
16	filled in the same manner as required for the member being replaced.
17	C. The commissioners shall serve without compensation, except per
18	diem or expense reimbursement to which they may be individually entitled as
19	members of their constituent organizations.
20	D. All commissioners shall be subject to the Code of Governmental
21	Ethics.
22	§3326. Bylaws; quorum
23	A. The board shall adopt such bylaws as it deems necessary or advisable
24	for conducting its business affairs by January 1, 2024. Such bylaws shall
25	include, but not be limited to:
26	(1) Procedures for the election of officers, including initial terms of
27	office and methods and grounds for removal of officers.
28	(2) Procedures and grounds for removal of commissioners, which shall
29	include, but not be limited to, felony conviction and failure of the commissioner

1	to meet board attendance requirements.
2	(3) Frequency of meetings.
3	(4) Appointment of standing and special committees as necessary to
4	carry out the purposes of this Chapter.
5	B. Before entering upon his official duties, each member of the board
6	shall take the oath of office provided by Article X, Section 30 of the Constitution
7	of Louisiana before an officer authorized by law to administer oaths.
8	C. A majority of the membership of the board shall constitute a quorum
9	for the transaction of business.
10	§3327. Powers and duties of the board
11	A. In order to accomplish the purposes for which the district is created,
12	the board may purchase, acquire by donation, hold, sell, and convey immovable
13	and movable property and execute such contracts as it may deem necessary or
14	convenient to enable it to properly carry out the purposes for which it is
15	created.
16	B. Notwithstanding any provision of law to the contrary, the board may
17	accept the transfer or donation of funds from the governing authorities of
18	parishes, municipalities, drainage districts, levee districts, and other political
19	subdivisions in the district.
20	C. Notwithstanding any provision of law to the contrary, the board may
21	contract with the federal government, the state, or any other public or private
22	entity to receive and expend funds to plan and perform projects for watershed
23	management.
24	D. The board may levy a district drainage tax on all property within the
25	boundaries of the district subject to taxation for drainage purposes. The tax
26	shall not be levied unless the proposition to levy the tax is approved by a
27	majority of the electors within the district boundaries who vote on the
28	proposition.
29	E. In addition to the duties defined elsewhere in this Chapter, the board

1	shall have the duty and authority to:
2	(1) Represent the public interest in supporting drainage, flood
3	reduction, and mitigation in the district.
4	(2) Advise state and local government agencies on issues concerning
5	drainage and the reduction and mitigation of flood risk in the district.
6	(3) Conduct public hearings and share public input on the community's
7	priorities relative to drainage, flood risk, and mitigation in the district.
8	(4) Enter into contracts, agreements, or cooperative endeavors with the
9	state and its political subdivisions and with any public or private entity to
10	promote the public purposes of the district.
11	(5) Construct and maintain drainage works of all types, either in
12	cooperation with public entities within the boundaries of the district, or upon
13	its own undertaking. Notwithstanding any other provisions of this Chapter to
14	the contrary, all works undertaken pursuant to the authority granted by this
15	Section shall be performed in accordance with the provisions of R.S. 38:2211,
16	et seq. Construction projects shall require approval of two-thirds of the total
17	voting membership of the board. All other decisions, including technical,
18	planning, and permitting decisions, shall require approval by a simple majority
19	of the total voting membership.
20	(6) Develop and recommend watershed management practices and
21	regional guidance within the district, insofar as those practices affect watershed
22	management, that address the following:
23	<u>(a) Planning.</u>
24	(b) Permitting.
25	(c) Selection and performance of projects and programs.
26	(d) Resolution of conflicts among agencies.
27	(e) Use of best available science.
28	(f) Outreach to the public and state and federal agencies.
29	(g) Coordination with state agencies and political subdivisions regarding

1	watershed management.
2	(h) Identifying, obtaining, and expending funding for planning and
3	projects, and entering into agreements with public and private entities.
4	(i) Entering into agreements with public and private entities to identify,
5	obtain, and expend funds.
6	(j) Assisting political subdivisions in planning, designing, and
7	constructing projects, and identifying and obtaining funding.
8	(k) Maintaining completed projects and programs.
9	(1) Defining qualifications for staff and contractors.
10	F. The board may develop a regional hazard mitigation plan consistent
11	with parish hazard mitigation plans.
12	G. The board shall consider the benefits of participating in the National
13	Flood Insurance Program Community Rating System (CRS) or any successor
14	or similar program, including how to maximize municipal participation in the
15	CRS. The board shall also consider and prioritize other available policies and
16	programs that can reduce flood risk and reduce flood insurance premiums.
17	H. The board may develop and implement a plan to manage and
18	maintain any waterways in the district, of state or regional concern, in relation
19	to matters impacting the district, in coordination with other federal, state, and
20	local water management jurisdictions and authorities.
21	I. The board shall develop a master plan for comprehensive drainage,
22	flood control, and water resource management through the construction and
23	management of projects and programs, including planning, permitting,
24	development, and waterway management. The plan should consider the Coastal
25	Protection and Restoration Authority Master Plan and provide for public
26	outreach.
27	J. The board, with the approval of the representative parish governing
28	authorities, shall appoint an administrative body to carry out the purposes of
29	this Chapter.

1	K. The division of administration, Department of Transportation and
2	Development, and the Coastal Protection and Restoration Authority shall not
3	displace, replace, or supplant state appropriations from the state general fund
4	or other state funds designated for the district.

<u>Proposed law</u> establishes the Acadiana Watershed District, provides for its purpose, and defines its geographic boundaries.

<u>Proposed law</u> provides for the district's corporate status and its authority to incur debt, for a domicile central to the district, for ownership, operation, and maintenance of a regional sensor network, and for recognition of the Louisiana Watershed Flood Center at UL-Lafayette as a regional data resource.

<u>Proposed law</u> provides for the responsibilities and auditing of the district and for its use, storage, and maintenance of the LWI Region 5 hydrologic and hydraulic model.

<u>Proposed law</u> establishes a board of commissioners to govern and manage the affairs of the district, provides for the membership appointments, for creation of bylaws, for meetings, for a technical advisory committee comprised of non-voting members, for compensation of board members, for terms, and for replacement of board members.

<u>Proposed law</u> provides for the powers of the board of commissioners, including that to acquire funding and property, to contract with public and private entities, to levy taxes on any property within the district subject to taxation, to advise state and local government on drainage and flooding issues, to conduct public hearings, to construct and maintain drainage works, to develop and recommend regional planning and practice guidance, and to develop and implement a waterway management plan and a comprehensive drainage, flood control, and water resource management plan.

<u>Proposed law</u> authorizes the district to develop a regional hazard mitigation plan that is consistent with parish hazard mitigation plans.

<u>Proposed law</u> precludes the division of administration, Dept. of Transportation and Development, and the Coastal Protection and Restoration Authority from displacing, replacing, or supplanting district funding.

Effective August 1, 2023.
