REAPPORTIONMENT/JUDGES: Provides for the redistricting of the Supreme Court

1 AN ACT

2 To enact R.S. 13:101.2 and 101.3 and to repeal R.S. 13:101, 101.1, and 312.4, relative to the  
3 supreme court; to provide relative to redistricting supreme court justice districts; to  
4 provide for the filling of vacancies; to eliminate statutory provisions for a temporary  
5 additional judgeship for the Court of Appeal for the Fourth Circuit and such judge's  
6 appointment to the supreme court; and to provide for related matters.

7 Be it enacted by the Legislature of Louisiana:

8 Section 1. R.S. 13:101.2 and 101.3 are hereby enacted to read as follows:

9 §101.2. Supreme court districts; justices

10 The state shall be divided into seven supreme court districts. The supreme  
11 court shall be composed of one justice elected from each of the seven districts as set

15       §101.3. Assignment of districts; vacancies, elections; redistricting

16            A. Each justice of the supreme court in office on January 1, 2024, shall be  
 17       the justice for the district having the same designation as the district from which the  
 18       justice was elected and shall complete the term for which he was elected.

19            B. The successor to the office of justice of the supreme court shall be elected  
 20       from the district assigned to that office as provided by Subsection A of this Section.  
 21       The election shall be from the district composed as provided by R.S. 13:101.2.

22       Section 2. R.S. 13:101, 101.1, and 312.4 are hereby repealed.

23       Section 3.(A) The precincts referenced in this Act are those contained in the file  
 24       named "2022 Precinct Shapefiles (12-25-2022)" available on the Louisiana House of  
 25       Representatives website on the effective date of this Section. The 2022 Precinct Shapefiles  
 26       are based upon those Voting Districts (VTDs) contained in the 2020 Census Redistricting  
 27       TIGER/Line Shapefiles for the state of Louisiana as those files have been modified and  
 28       validated through the data verification program of the Louisiana House of Representatives  
 29       and the Louisiana Senate to represent precinct changes submitted through December 25,

1 2022, to the Legislature of Louisiana by parish governing authorities pursuant to the  
2 provisions of R.S. 18:532 and 532.1.

3 (B) When a precinct referenced in this Act has been subdivided by action of the  
4 parish governing authority on a nongeographic basis or subdivided by action of the parish  
5 governing authority on a geographic basis in accordance with the provisions of R.S.  
6 18:532.1, the enumeration in this Act of the general precinct designation shall include all  
7 nongeographic and all geographic subdivisions thereof, however such subdivisions may be  
8 designated.

9 (C) The territorial limits of the districts as provided in this Act shall continue in  
10 effect until changed by law regardless of any subsequent change made to the precincts by  
11 the parish governing authority.

12 Section 4.(A) Solely for the purposes of qualifying for election and the election of  
13 a member of the supreme court from District 2 at the regularly scheduled election for such  
14 office in 2023, the provisions of Section 1 of this Act shall become effective upon signature  
15 of this Act by the governor or, if not signed by the governor, upon expiration of the time for  
16 bills to become law without signature by the governor, as provided in Article III, Section 18  
17 of the Constitution of Louisiana. If this Act is vetoed by the governor and subsequently  
18 approved by the legislature, the provisions of Section 1 of this Act shall become effective  
19 on the day following such approval for the purposes established in this Subsection.

20 (B) For subsequent elections of members of the supreme court and for all other  
21 purposes, the provisions of Section 1 of this Act shall become effective on January 1, 2024.

22 (C) The provisions of Section 2 of this Act shall become effective on January 1,  
23 2024.

24 (D) The provisions of this Section and Section 3 of this Act shall become effective  
25 upon signature of this Act by the governor or, if not signed by the governor, upon expiration  
26 of the time for bills to become law without signature by the governor, as provided in  
27 Article III, Section 18 of the Constitution of Louisiana. If this Act is vetoed by the governor  
28 and subsequently approved by the legislature, the provisions of this Section and Section 3  
29 of this Act shall become effective on the day following such approval.

**Abstract:** Provides for the redistricting of the state's supreme court and provides for the composition of seven supreme court districts. Effective for election purposes for the regular supreme court District 2 election in 2023 and for all purposes on Jan. 1, 2024.

Statistical summaries of proposed law including maps illustrating proposed district boundaries accompany this digest. *(Attached to the bill version on the internet.)*

Present constitution (Const. Art. V, §3) provides the supreme court must be composed of a chief justice and six associate justices.

Present constitution (Const. Art. V, §4) provides the state must be divided into at least six supreme court districts, and at least one judge shall be elected from each. Further provides the districts and the number of judges assigned to each on the effective date of this constitution are retained, subject to change by law enacted by two-thirds of the elected members of each house of the legislature.

Proposed law redraws district boundaries for the seven supreme court districts.

Proposed law provides the district boundaries will be effective upon signature of the governor or lapse of time for gubernatorial action for the purposes of qualifying for election and the election of a member of the supreme court from District 2 at the regularly scheduled election for such office in 2023.

Proposed law provides for subsequent elections of members of the supreme court and for all other purposes an effective date of Jan. 1, 2024, at which time present law is repealed and proposed districts are effective for all other purposes.

Proposed law repeals present law that provides for an additional judgeship for the Court of Appeal for the Fourth Circuit who is assigned to the La. Supreme Court.

Proposed law specifies that precincts referenced in district descriptions are those precincts identified in the file named "2022 Precinct Shapefiles (12-25-2022)" available on the La. House of Representatives website. Specifies that the 2022 Precincts are based upon those Voting Districts (VTDs) contained in the 2022 Census Redistricting TIGER/Line Shapefiles for the state of La. as validated through the data verification program of the La. legislature. Also specifies that if any such precinct has been subdivided by action of the parish governing authority on a nongeographic basis or subdivided by action of the parish governing authority on a geographic basis in accordance with present law, the enumeration of the general precinct designation shall include all nongeographic and all geographic subdivisions thereof. Further provides that the territorial limits of the districts as enacted shall continue in effect until changed by law regardless of any subsequent change made to the precincts by the parish governing authority.

Population data in the summaries accompanying this digest are derived from 2020 Census Redistricting Data (Public Law 94-171), Summary File for Louisiana. Population data, statistical information, and maps are supplied for purposes of information and analysis and comprise no part of proposed law.

Effective for election purposes only for the supreme court District 2 election in 2023;  
effective for other purposes Jan. 1, 2024.

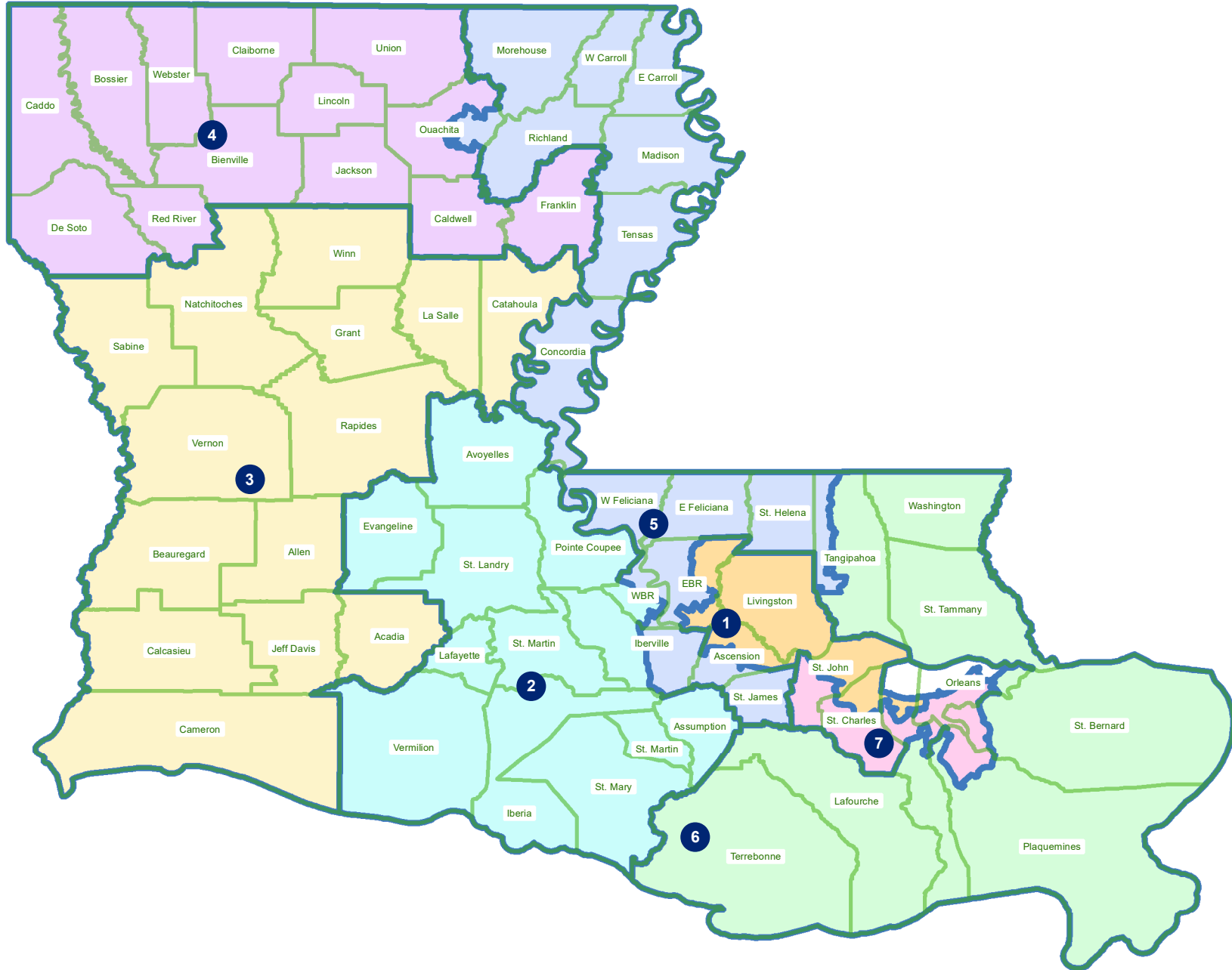

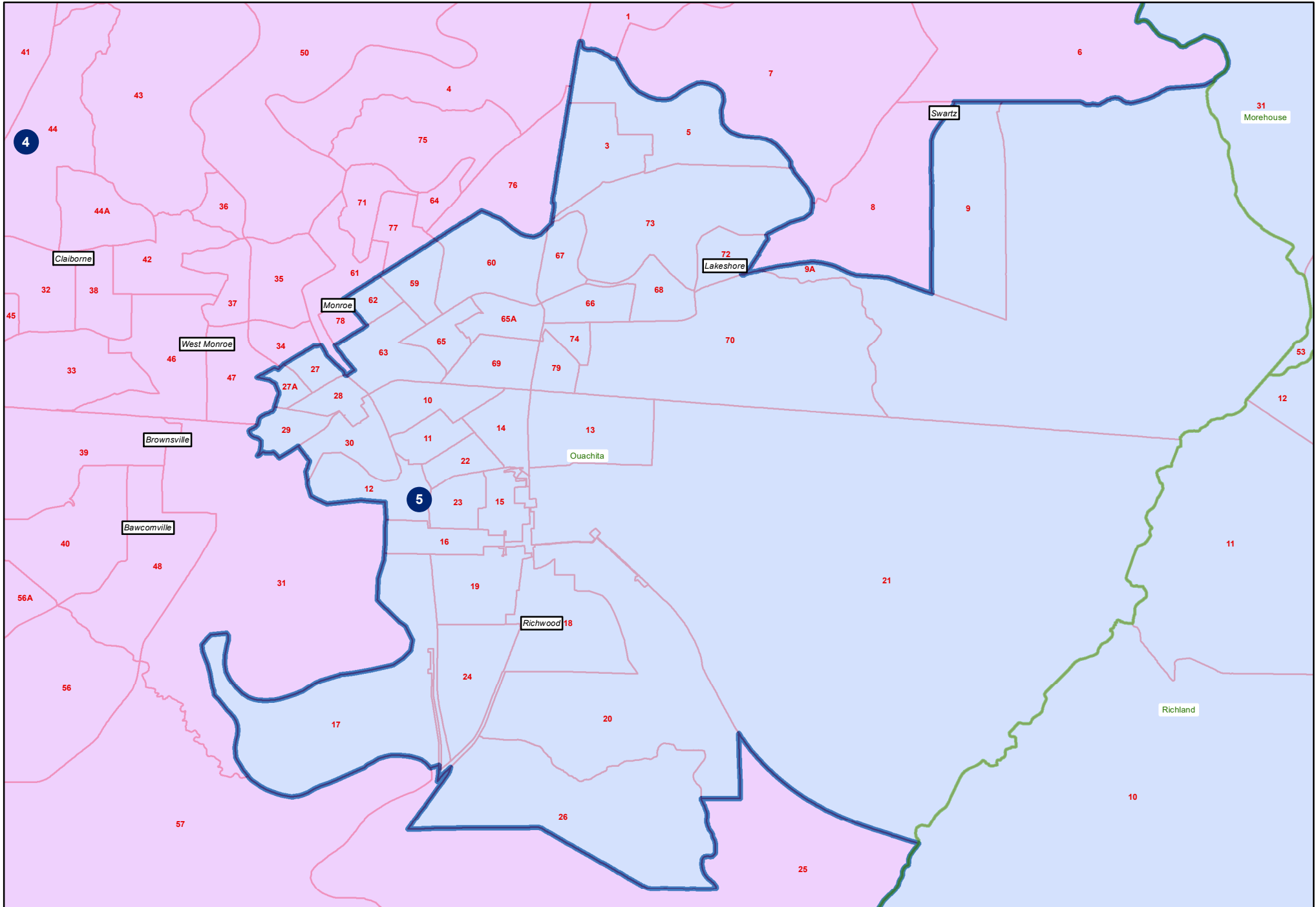

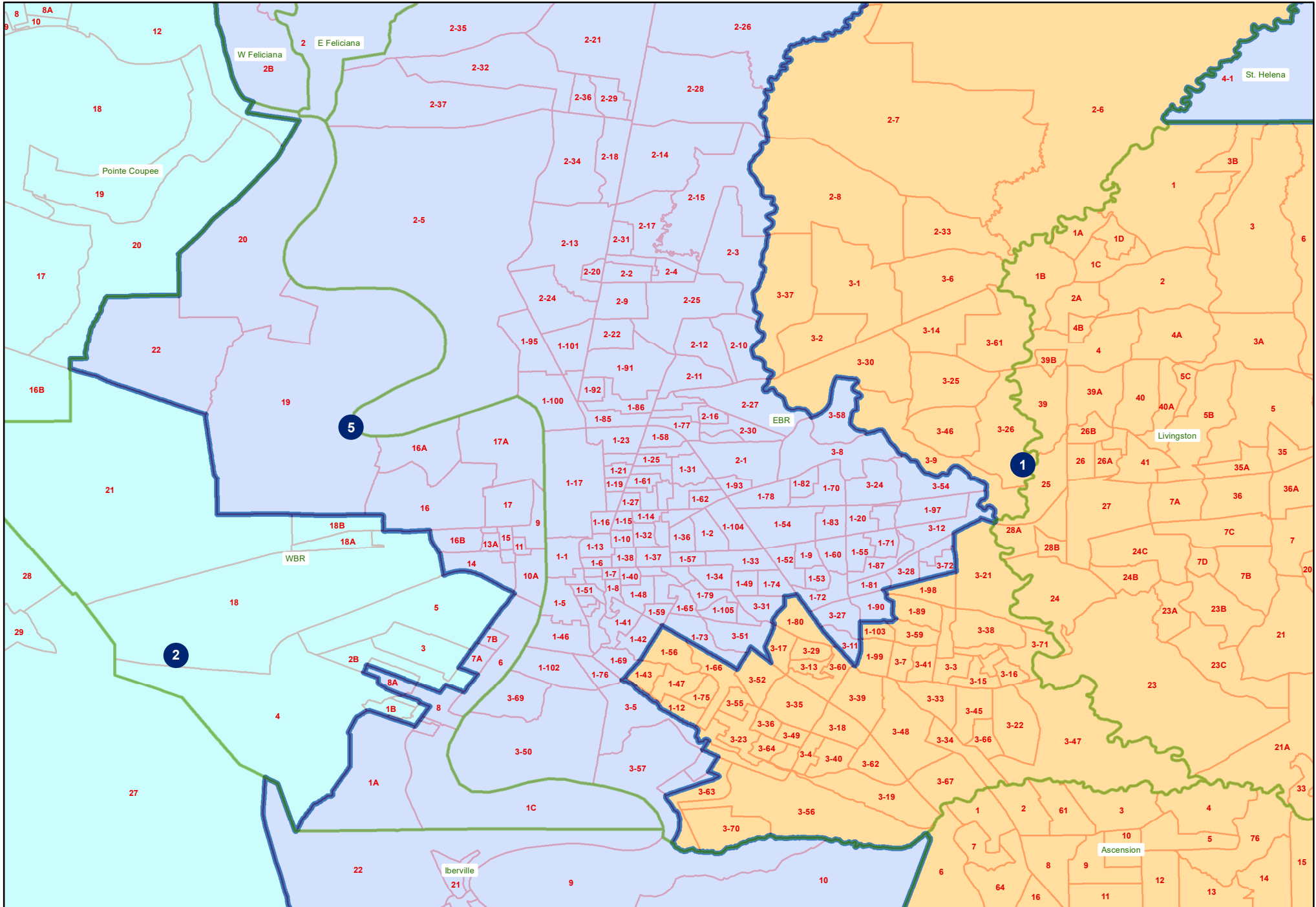
