AN ACT

HEALTH/SMOKING: Provides relative to a smoking cessation benefits

2	To enact R.S. 40:1295, relative to a smoking cessation benefits program; to establish and
3	promote a program to assist with smoking cessation; to provide for healthcare
4	coverage for smoking cessation benefits; to provide for the promulgation of rules and
5	regulations; to provide for definitions; and to provide for related matters.
6	Be it enacted by the Legislature of Louisiana:
7	Section 1. R.S. 40:1295 is hereby enacted to read as follows:
8	§1295. Smoking cessation benefits program; coverage
9	A. For the purposes of this Section, the following terms have the following
10	meanings:
11	(1) "Department" means the Louisiana Department of Health.
12	(2) "Smoking cessation benefits" means the smoking cessation treatments
13	and services, including individual counseling, group counseling, nicotine patches,
14	nicotine gum, nicotine lozenges, nicotine nasal spray, nicotine inhaler, bupropion,
15	and varenicline.
16	B.(1) All private insurance plans and Medicaid shall provide coverage for
17	comprehensive smoking cessation benefits to any resident of this state for a period
18	of three months if a licensed physician recommends and certifies that the smoking
19	cessation benefits may help the resident to quit smoking.

1 (2) The smoking cessation benefits coverage required by this Subsection shall not be subject to any co-payments, deductibles, or other cost-sharing 2 3 mechanisms. 4 C.(1) The department shall develop and implement a public awareness campaign to inform the residents of this state about the availability of smoking 5 6 cessation benefits. The campaign shall include but not be limited to the use of public 7 service announcements, print and digital media, and partnerships with community 8 organizations and healthcare providers. 9 (2) The department shall promulgate and enforce such rules, regulations, and 10 minimum standards as needed to carry out the provisions of this Section.

**Abstract:** Establishes a program to encourage and assist the public to quit smoking.

<u>Proposed law</u> provides that individuals may receive any of the smoking cessation benefits for a three month period with all costs paid by private insurance, or Medicaid, if applicable. Smoking cessation benefits include but are not limited to nicotine patches, nicotine lozenges, and prescription drugs.

<u>Proposed law</u> directs the La. Department of Health to promulgate rules and regulations necessary to enforce the provisions of this Section and to promote the availability of the smoking cessation benefits.

Proposed law provides for definitions.
