CONDOLENCES: Expresses condolences on the death of Wayne Touchet

1                           A CONCURRENT RESOLUTION

2     To express the condolences of the Legislature of Louisiana upon the death of Wayne  
3                           Touchet.

4                           WHEREAS, it is with immense sadness and profound regret that the Legislature of  
5     Louisiana has learned of the death of Wayne Touchet; and

6                           WHEREAS, Mr. Touchet is remembered as an incredibly selfless individual who was  
7     always willing to offer help to anyone in need, especially his fellow community members  
8     in Vermilion Parish; at the time of his passing, he was serving his fifth term as the Vermilion  
9     Parish Police Juror for District 5; and

10                          WHEREAS, outside of his role as a police juror, Wayne worked as a building  
11     contractor and as a detective with the Vermilion Parish Sheriff's Office; he was known for  
12     regularly assisting Vermilion Parish residents with housing projects by offering to do  
13     carpentry work or send his own staff to help; and

14                          WHEREAS, Wayne represented District 5 on the Vermilion Parish Police Jury for  
15     eighteen years; he also served as president of the police jury in 2010 and 2011; he and his  
16     fellow police jurors worked closely with state and other local officials to pool resources in  
17     order to complete projects that benefitted the residents of the city of Abbeville and  
18     Vermilion Parish; he brought a unique perspective to the jury as a former contractor with  
19     extensive knowledge of building codes and construction projects; and

1        WHEREAS, Mr. Touchet was also highly engaged with the citizens of Vermilion  
2 Parish and acted as a true public servant following the devastation wrought by Hurricanes  
3 Gustav and Ike; and

4        WHEREAS, Wayne Touchet leaves to cherish his memory his wife, Elizabeth "Liz"  
5 Comeaux Touchet, six children, twenty-two grandchildren, and ten great-grandchildren; he  
6 was a true servant of the people who placed community needs above his own; he will be  
7 deeply missed but certainly never forgotten.

8        THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby  
9 express heartfelt condolences on the death of Wayne Touchet; does hereby further recognize  
10 Mr. Touchet's unrelenting dedication to Vermilion Parish and the state of Louisiana; and  
11 does hereby extend sincerest wishes that his family, friends, and loved ones find comfort in  
12 their shared memories of his life.
