REVENUE DEPARTMENT OR NO IMPACT See Note Page 1 of 1  
Requires agency referrals of delinquent debt to the office of debt recovery for collection to include certain information

Current law requires agencies referring delinquent debt to the office for collection to include data and information in the referral in a format necessary to institute collection procedures. It further requires delinquent debt to be authenticated by the agency or officer prior to being referred to the office.

Proposed law retains present law but requires the agency referral to include a description of the original obligation or offense and the amount assessed against the person, an itemization of each agency that has attempted to collect the delinquent debt including any additional fees, fines, penalties, or charges imposed by each agency, an itemization of all payments made by the debtor, and any additional information requested by the Office of Debt Recovery (ODR).

**EXPENDITURE EXPLANATION**

The Legislative Fiscal Office (LFO) anticipates each department referring delinquent debt can accomplish these tasks utilizing existing resources as similar changes are enacted annually by legislative instruments and paid from base funding. To the extent that numerous pieces of legislation are enacted that require additional programming efforts, departments may require additional resources.
