Current law limits appropriations for the M.J. Foster Promise Program with a cap of \$10 M per year for public postsecondary institutions and a separate cap of \$500,000 for proprietary schools. Proposed legislation combines the two allocations together into a single appropriation capped at \$10.5 M for students in either a public postsecondary institution or a proprietary school.
