- 11 "B.(1) Except as provided in R.S. 40:1749.15, prior to any excavation or 12 demolition, each excavator or demolisher shall serve telephonic or electronic notice 13 of the intent to excavate or demolish to the regional notification center or centers 14 serving the area in which the proposed excavation or demolition is to take place. 15 Such notice shall be given to the notification center at least forty-eight hours, but not 16 more than one hundred twenty hours, excluding weekends and holidays, in advance 17 of the commencement of any excavation or demolition activity. Furthermore, 18 excavation or demolition activities shall commence not more than one hundred and 19 twenty hours past the mark-by-time. Holidays shall consist of the following: New 20 Year's Day; Martin Luther King, Jr. Day; Good Friday; Memorial Day; 21 Independence Day; Labor Day; Thanksgiving Day; Christmas Eve; and Christmas 22 Day."

- 25 On page 2, delete lines 20 through 25 and insert in lieu thereof:
- 26 "(4) Dig test pits to determine the actual location of facilities or utilities 27 handling electricity, gas, natural gas, oil, petroleum products, or other flammable, 28 toxic, or corrosive fluids/gases if these facilities or utilities are to be exposed. Pot 29 holes to determine the actual location of such facilities or utilities if an excavation 30 or demolition operation could result in damage to underground utilities or facilities handling electricity, gas, natural gas, oil, petroleum products, or other flammable, 31 toxic, or corrosive fluids or gases. For forestry excavation operations that could 32 33 result in damage to underground utilities or facilities handling electricity, gas, natural gas, oil, petroleum products, or other flammable, toxic, or corrosive fluids or gases, 34 35 the forestry excavator and the utility or facility owner or operator shall cooperate to 36 determine the actual location of such facilities or utilities."
