 - "(3)(a) If fewer than one thousand qualified electors reside within the voting area electors voted for the public official in the most recent contest electing the public official to his office, the petition shall be signed by at least forty percent of the the same number of electors who voted for the public official.
 - (b) If one thousand or more but fewer than twenty-five thousand qualified electors reside within the voting area electors voted for the public official in the most recent contest electing the public official to his office, the petition shall be signed by at least thirty-three and one-third fifty percent of the number of electors who voted for the public official.
 - (c) If the public official was elected in a special election or elected without opposition, the petition shall be signed by the appropriate percentage, as provided in Subparagraphs (a) and (b) of this Paragraph, of the number of electors in the voting area who voted for the prevailing candidate in the most recent regularly scheduled election for an office that encompassed the voting area."
