Abstract: Permits a qualifying nursing student to be licensed or certified in a nursing profession with lesser educational requirements.

<u>Present law</u> states that a licensed practical nurse (LPN) must graduate from an approved LPN program.

<u>Proposed law</u> retains <u>present law</u> and permits a student to register as an LPN if he successfully completes an education program for registered nurses.

<u>Proposed law</u> permits a nursing student who completes a course in the fundamentals of nursing offered by a practical or registered nursing program shall be required to complete a certified nursing training or competency evaluation program. Upon passing the evaluation, the student may register and practice as a certified nurse aide (CNA) in this state.

Summary of Amendments Adopted by House

The Committee Amendments Proposed by <u>House Committee on Health and Welfare</u> to the <u>original</u> bill:

- 1. Require an applicant to successfully complete either an education program for practical nurses or an education program for registered nurses.
- 2. Make technical changes.

The House Floor Amendments to the engrossed bill:

1. Require a prospective certified nurse aide who has completed a semester of courses in an education program for registered nurses or licensed practical nurses to take a certified nurse aide competency evaluation prior to registering with the Louisiana Certified Nurse Aide Registry.
