Provides relative to certain practices of public postsecondary institutions. (8/1/23)

Proposed legislation prohibits public postsecondary institutions from using a student's or their family member's race, sex, or national origin as a factor for admission to the institution or a program of study and consideration for scholarships and financial aid awarded by the institution. Provides that scholarships and financial aid programs provided for by donors or special programs which require preferential treatment are exempt from the requirements in proposed legislation. Requires all public postsecondary institutions to provide a report to the House and Senate Education Committees on the scholarships and financial aid programs which require the consideration of a student's race, sex, or national origin by November 1, 2023. Students may seek a writ of mandamus or injunctive relief to require an institution comply with the proposed law.
