Creates database to track trafficking arrests, convictions, restitution, fines, and civil asset forfeiture. (8/1/23)

Present law provides the legal definition of criminal justice agency. Proposed law amends present law to add the Governor's Office of Human Trafficking Prevention to the legal definition of criminal justice agency.

Present law provides a list of obligations imposed on the Department of Children and Family Services (DCFS), the Louisiana Department of Health (LDH), and the Governor's Office of Human Trafficking Prevention (GOHTP) in providing services to children and adults who are victims of human trafficking. Present law mandates that private entities and statewide and local law enforcement entities that provide services to human trafficking victims submit to DCFS and GOHTP an annual report on their operations. Proposed law amends present law and adds a mandate for each district attorney that provides services to or prosecutes cases involving child and adult victims of human trafficking to submit an annual report on their operations to the GOHTP and the DCFS.
