17 with application of a minor for any credential authorized in this Chapter which
18 allows the operation of a motor vehicle. The provisions of this Subsection shall not
19 apply to a first or initial issuance of any license or permit under this Chapter. The
20 first time or initial issuance shall be an in-person transaction."
