SCHOOLS/FOOD PROGRAMS: Requires free school breakfast and lunch for certain students

1 AN ACT

2 To enact R.S. 17:192(B)(3), relative to school meals; to provide that certain students shall
3 be provided free school breakfast and lunch; to provide for applicability; to require
4 reimbursement by the state Department of Education; and to provide for related
5 matters.

6 Be it enacted by the Legislature of Louisiana:

7 Section 1. R.S. 17:192(B)(3) is hereby enacted to read as follows:

8 §192. Lunches and breakfasts; duty to furnish

9 * * *

10 B.

11 * * *

12 (3)(a) Notwithstanding any provision of law to the contrary, an eligible
13 student shall be provided a free breakfast and lunch.

14 (b) For purposes of this Paragraph, an eligible student is a student who meets
15 the federal eligibility guidelines for reduced price meals by household size and
16 income levels pursuant to the national school breakfast and school lunch programs.

17 (c) For each breakfast or lunch served free of charge in accordance with this
18 Paragraph, the state Department of Education shall reimburse the governing
19 authority of a nutrition program provider for the meal an amount equal to the

1 difference between the reimbursement rates provided by the United States
2 Department of Agriculture for a free meal and a reduced-price meal.

3 Section 2. The provisions of R.S. 17:192(B)(3) as enacted by this Act shall be
4 implemented beginning with the 2023-2024 school year.

Abstract: Requires free school breakfast and lunch for certain public school students.

Present law provides for the provision of school meals. Proposed law:

- (1) Provides that students who qualify for reduced-price meals shall be provided a free breakfast and lunch.
- (2) Provides that for each breakfast or lunch served free of charge in accordance with proposed law, the state Dept. of Education shall reimburse the governing authority of a nutrition program provider for the meal an amount equal to the difference between the reimbursement rates provided by the U.S. Dept. of Agriculture for a free meal and a reduced-price meal.
- (3) Provides that proposed law shall be implemented beginning with the 2023-2024 school year.

Summary of Amendments Adopted by House

The Committee Amendments Proposed by House Committee on Education to the original bill:

1. Limit applicability of proposed law to students who qualify for reduced-price school meals.
2. Require reimbursement by the state Dept. of Education.
