13 On page 1, line 16, after "zydeco," delete the remainder of the line and insert "cajun, jazz,
14 rhythm and blues, hip-hop, and gospel music throughout Louisiana."

16 On page 2, at the end of line 7, delete "parish or" and at the beginning of line 8, change
17 "municipality" to "political subdivision"

19 On page 2, line 14, between "development" and "or" insert a comma ","

21 On page 2, line 16, delete "director of byways and trails," and insert "assistant secretary of
22 the"

4 On page 3, line 1, after "development" change "of" to "or"

5 AMENDMENT NO. 14

6 On page 3, line 10, delete "based on music projects that focus" and insert "that focuses"

7 AMENDMENT NO. 15

8 On page 3, line 13, after "and roll," delete the remainder of the line and delete line 14 and
9 insert "country, zydeco, cajun, jazz, rhythm and blues, hip-hop, and gospel music."

10 AMENDMENT NO. 16

11 On page 3, line 15, after "and the" delete the remainder of the line and insert "office of
12 tourism"

13 AMENDMENT NO. 17

14 On page 3, delete lines 19 and 20, and insert "opportunities to encourage the development
15 of exhibits related to the musical heritage of the region."

16 AMENDMENT NO. 18

17 On page 3, line 22, after "Section" change the comma "," to a period "." and delete the
18 remainder of the line and delete line 23

19 AMENDMENT NO. 19

20 On page 4, line 6, after "music" change "projects" to "routes"

21 AMENDMENT NO. 20

22 On page 4, line 8, delete "economic development opportunities" and insert "tourism
23 marketing and promotion"

24 AMENDMENT NO. 21

25 On page 4, delete lines 10 through 17 and insert the following:

26 "(3) The qualified routes approved by the commission and added to the
27 Louisiana Music Trail during the biennium for which the report is being made,
28 including the following:

29 (a) The name of the political subdivision that applied for approval of the
30 route.

31 (b) A description of the music history and significance of the route.

32 (c) The location of the route including the start and end points."

33 AMENDMENT NO. 22

34 On page 4, delete line 19 through 22, and insert the following:

35 "A. The Department of Transportation and Development or its contractors
36 shall erect appropriate signage, in accordance with the manual on uniform traffic

1 control devices, reflecting those highways or sections of highways designated
2 pursuant to this Part as the Louisiana Music Trail if funds are received by the
3 department equal to the department's actual costs for material, fabrication, mounting
4 posts, and installation of each sign."

5 AMENDMENT NO. 23

6 On page 5, line 1, between "state" and "maps" change "highways" to "highway"

7 AMENDMENT NO. 24

8 On page 5, line 3, change "36:209(D)(4)" to "36:209(A)(10)"

9 AMENDMENT NO. 25

10 On page 5, delete lines 6 through 11, and insert the following:

11 "A. The following agencies are transferred to and hereafter shall be within
12 the Department of Culture, Recreation and Tourism in accordance with the
13 provisions of R.S. 36:901 et seq. except as otherwise provided by this Subsection:

14 * * *

15 (10) The Louisiana Music Trail Commission (R.S. 56:1950.23)."
