2	To commend Deputy Christopher Hogan of the West Baton Rouge Parish Sheriff's Office

4	WHEREAS, Deputy Hogan has served as a uniformed patrol officer with the West
5	Baton Rouge Sheriff's Office since 2021; he faced unthinkable adversity just one year into
6	his tenure and used an incredible display of rapid judgment to prevent further tragedy; and
7	WHEREAS, Deputy Hogan responded to a call for backup from a Louisiana
8	Department of Transportation and Development Motorist Assistance Patrol (MAP) worker
9	on Interstate-10 West on November, 20, 2022; upon arrival, he witnessed the MAP worker
10	being stabbed by another individual; and
11	WHEREAS, Deputy Hogan immediately ran towards the suspect, ordering him to
12	stop, but the suspect charged at Deputy Hogan; recognizing the threat, Deputy Hogan
13	discharged his weapon, eliminating the immediate threat, called for medical assistance,
14	handcuffed the suspect, and rendered aid; and
15	WHEREAS, Deputy Hogan is known for his humility and positive attitude among
16	his peers at the West Baton Rouge Sheriff's Office; although he is quiet, he displays a sincere
17	willingness to go out of his way for anyone in need; and
18	WHEREAS, West Baton Rouge Parish Sheriff's Deputy Christopher Hogan is the
19	recipient of the 2023 Louisiana Sheriffs' Association Deputy Valor Award for his
20	extraordinary judgment and bravery during this harrowing situation; he is most deserving
