2 To amend and reenact R.S. 40:2009.25(C)(9), (D)(9), and (E)(10), relative to nursing homes  
3 licensed by the Louisiana Department of Health; to provide requirements and  
4 standards for nursing home emergency preparedness plans; to authorize the  
5 Louisiana Department of Health to take certain actions relative to nursing homes;  
6 and to provide for related matters.

7 Be it enacted by the Legislature of Louisiana:

8 Section 1. R.S. 40:2009.25(C)(9), (D)(9), and (E)(10) are hereby amended and  
9 reenacted to read as follows:

10 §2009.25. Emergency preparedness plans for nursing homes; requirements; Nursing  
11 Home Emergency Preparedness Review Committee; rules and regulations
