Establishes a chief resilience officer and provides for interagency coordination of resilience planning

Proposed law creates the Chief Resilience Officer (CRO) in statute as a position within the Office of the Governor to build long-term economic and environmental resilience for Louisiana residents. The position is appointed by the governor, and confirmed by the Senate. Duties of the CRO include coordinating the newly created Interagency Resilience Coordination Team and the Louisiana Resilience Task Force. Provides for the membership of the Resilience Coordination Team and the Resilience Task Force. Provides for the development and submission of an annual statewide resilience report.
