2	To amend and reenact R.S. 40:1379.1.4(B)(5), relative to the carrying of concealed weapons
3	by qualified retired law enforcement officers; to provide relative to annual
4	qualification; and to provide for related matters.
5	Be it enacted by the Legislature of Louisiana:
6	Section 1. R.S. 40:1379.1.4(B)(5) is hereby amended to read as follows:
7	§1379.1.4. Carrying of concealed firearms by qualified retired law enforcement

0	B. As used in this Section, the term "qualified retired law enforcement
1	officer" means an individual who meets all of the following:

**Abstract:** Provides relative to the requirement of P.O.S.T. certification for the use of firearms by qualified retired law enforcement officers.

<u>Present law</u> (R.S. 40:1379.1.4) permits an individual who is a qualified retired law enforcement officer to carry a concealed firearm anywhere in the state, including any place open to the public, if he meets certain eligibility criteria.

Proposed law retains present law.

<u>Present law</u> (R.S. 40:1379.1.4(B)(5)) requires a qualified retired law enforcement officer to qualify annually for P.O.S.T. Council certification and to provide proof of such certification.

<u>Proposed law</u> amends <u>present law</u> to require that the qualified retired law enforcement officer was properly certified by the P.O.S.T. Council at the time of retirement, in accordance with <u>present law</u> (R.S. 40:1379.3(D)(1)(f)).
