UTILITIES: Creates a study group to study the barriers to deploying broadband across public and private property

1	A RESOLUTION
2	To create and provide for a study group to study the barriers to deploying broadband across
3	public and private property and to report its findings, along with proposed legislation
4	to remove barriers to deployment across public and private property, to the House
5	of Representatives no later than forty-five days prior to the convening of the 2024
6	Regular Session of the Legislature of Louisiana.
7	WHEREAS, several hundred thousand households throughout Louisiana lack access
8	to broadband service; and
9	WHEREAS, the continued lack of access to broadband service in this state presents
10	challenges to individuals residing and businesses operating in this state; and
11	WHEREAS, the state of Louisiana received more than one hundred seventy-six
12	million dollars from the American Rescue Plan's Coronavirus Capital Projects Fund (CPF)
13	to expand access to broadband in the state; and
14	WHEREAS, the office of broadband development and connectivity has awarded
15	broadband providers CPF monies for the deployment of broadband to unserved areas
16	through the Granting Unserved Municipalities Broadband Opportunities (GUMBO) grant
17	program; and
18	WHEREAS, any unused CPF monies must be returned to the United States
19	Department of Treasury by December 31, 2026; and
20	WHEREAS, it is estimated that the state will receive an additional one billion dollars
21	through the Broadband Equity, Access, and Deployment (BEAD) Program of the United

1	States Department of Commerce's National Telecommunications and Information			
2	Administration to further expand access to broadband in the state; and			
3	WHEREAS, acquiring rights to access and use of public and private property,			
4	including rights-of-way and servitudes, for broadband deployment can be a lengthy process			
5	that impedes broadband deployment; and			
6	WHEREAS, delays in deploying broadband in the state puts the state's federal			
7	funding for broadband at risk.			
8	THEREFORE, BE IT RESOLVED that the House of Representatives of the			
9	Legislature of Louisiana does hereby create a study group to study the barriers to deploying			
10	broadband across public and private property and does hereby request the study group to			
11	report its findings, along with proposed legislation to remove barriers to deployment across			
12	public and private property, to the House of Representatives no later than forty-five days			
13	prior to the convening of the 2024 Regular Session of the Legislature of Louisiana.			
14	BE IT FURTHER RESOLVED that the study group shall be comprised of the			
15	following members:			
16	(1) The secretary of the Department of Transportation and Development or his			
17	designee.			
18	(2) The executive director of the office of broadband development and			
19	connectivity or his designee.

21	Cooperatives or his designee.			
22	(4) The chief executive officer of the Cellular Telecommunications Industry			
23	Association or his designee.			
24	(5) The president of the Louisiana Association of Business and Industry or his			
25	designee.			
26	(6) The executive director of the Louisiana Internet and Television-The			
27	Broadband Association or his designee.			
28	(7) The president of the Louisiana Landowners Association or his designee.

18	as provided herein shall be submitted to the chairman of the study group on or before July			
19	31, 2023.			
20	BE IT	FURTHER RESOLVED that the study group shall submit a written report of		
21	its findings and proposed legislation to the House of Representatives no later than forty-five			
22	days prior to the convening of the 2024 Regular Session of the Legislature of Louisiana.			
23	BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to the			
24	secretary of the Department of Transportation and Development, the executive director of			
25	the office of broadband development and connectivity, the chief executive officer of the			
26	Association of Louisiana Electric Cooperatives, the chief executive officer of the Cellular			
27	Telecommunications Industry Association, the president of the Louisiana Association of			
28	Business and Industry, the executive director of the Louisiana Internet and Television-The
