Amendments proposed by House Committee on Ways and Means to Engrossed Senate Bill No. 132 by Senator Reese

1 AMENDMENT NO. 1

2 On page 1, line 2, after "R.S. 39:128(B)(4)(a)(i)" and before "relative" delete the comma ","
3 and insert "and (C) and to enact R.S. 39:121(8) and (9),"

4 AMENDMENT NO. 2

5 On page 1, line 5, after "projects;" and before "and to" insert the following:

6 "to exempt certain projects from being included in the capital outlay budget; to
7 authorize the office of facility planning and control to delegate administration of projects
8 under certain circumstances; to authorize the office of facility planning and control to utilize
9 third-party management firms under certain circumstances; to provide for certain limitations
10 and requirements;"

11 AMENDMENT NO. 3

12 On page 1, line 7, after Section 1." delete the remainder of the line in its entirety and insert
13 the following:

14 "R.S. 39:128(B)(4)(a)(i) and (C) are hereby amended and reenacted and R.S.
15 39:121(8) and (9) are hereby enacted to read as"

16 AMENDMENT NO. 4

17 On page 1, between lines 8 and 9, insert the following:

18 "§121. Division of administration powers, duties, and functions

19 The division of administration in accordance with the provisions of R.S.
20 39:1410 in order to exercise supervision over the expenditure of funds and the
21 construction projects, shall specifically:

23 **(8) Have the authority, through the office of facility planning and**
24 **control, to delegate administration of projects as it deems necessary to a state**
25 **agency or higher education management board through the approval and**
26 **execution of a cooperative endeavor agreement for the planning, design,**
27 **bidding, contracting, construction, and management of such projects.**

28 **(9) Have the authority, through the office of facility planning and**
29 **control, to utilize the services of contracted third-party management firms to**
30 **assist with the administration and management of capital outlay projects.**

1 AMENDMENT NO. 5

2 On page 2, after line 11, insert the following:

3 "C. Except as provided by Subsection B of this Section, ~~minor~~ repairs,
4 renovations, or construction of buildings or other facilities may be undertaken by an
5 agency without being included in the capital outlay budget, provided that the
6 ~~expenditures for a fiscal year~~ cost for these undertakings do **repairs, renovation, or**
7 **construction of buildings or other facilities for each individual project** does not
8 exceed ~~one~~ two hundred fifty thousand dollars ~~cumulatively per agency and the~~
9 ~~expenditures are first approved by the commissioner of administration and the Joint~~
10 ~~Legislative Committee on the Budget.~~ For the purpose of this Subsection, "cost"
11 shall not be construed to include design fees or movable equipment.
