Prefiled pursuant to Article III, Section 2(A)(4)(b)(i) of the Constitution of Louisiana. WEAPONS/HANDGUNS: Provides relative to the concealed carrying of firearms

2	To amend and reenact R.S. 14:95(M)(1) and (2) and R.S. 40:1379.3(B)(2)(a), 1379.3.3(B),
3	(D)(1) and (6), and (F)(2), to enact R.S. 14:95(N) and R.S. 40:1379.3.3(D)(9), and
4	to repeal R.S. 14:95(M)(3), relative to the illegal carrying of weapons; to exempt
5	certain persons from the crime of illegal carrying of weapons; to provide relative to
6	concealed handgun permits; to provide relative to the authority of a person to carry
7	a concealed handgun without a permit; to provide for a restriction; to provide relative
8	to an online education course; to provide relative to course topics; and to provide for
9	related matters.

11	Section 1. R.S. 14:95(M)(1) and (2) are hereby amended and reenacted and R.S.

Abstract: Exempts certain persons from the crime of illegal carrying of weapons and removes the requirement that a person possess a permit issued by the state of La. in order to carry a concealed handgun in the state of La.

<u>Present law</u> (R.S. 14:95) prohibits the carrying of a concealed firearm, provides for criminal penalties, and provides for certain exceptions to the offense.

<u>Proposed law</u> amends <u>present law</u> to create an exception to this prohibition for a person located in La. who is 18 years of age or older and who is not prohibited from possessing a firearm under any federal or state law.

<u>Proposed law</u> provides that any person carrying a weapon pursuant to <u>proposed law</u> (R.S. 14:95(M)) shall be subject to the restrictions contained in <u>present law</u> (R.S. 40:1379.3(M) and (N)).

<u>Present law</u> (R.S. 40:1379.3) provides that La. residents who meet certain eligibility requirements may apply for and be issued a concealed handgun permit authorizing the

person to carry a concealed handgun on his person in the state of La. Further requires the person to possess a valid concealed handgun permit issued by the state of La. in order to carry a concealed handgun in the state of La.

Proposed law retains present law.

<u>Present law</u> (R.S. 40:1379.3(B)(2)(a)) provides that a La. resident who meets the qualifications of <u>present law</u> (R.S. 14:95(M)) shall not be required to possess a valid concealed handgun permit issued by the state of La. pursuant to <u>present law</u> in order to carry a concealed handgun in the state of La. Further provides that the provisions of <u>present law</u> shall not affect the requirements of reciprocity.

<u>Proposed law</u> amends <u>present law</u> to provide that a person who meets the qualifications of <u>present law</u> (R.S. 14:95(M)) shall not be required to possess a valid concealed handgun permit issued by the state of La. pursuant to <u>present law</u> in order to carry a concealed handgun in the state of La.

<u>Present law</u> (R.S. 40:1379.3.3) provides that the DPS&C, office of state police, shall provide a two-hour online handgun education course at no cost to La. residents.

Proposed law retains present law.

<u>Present law</u> provides for the length of the online course to be two hours.

<u>Proposed law</u> amends <u>present law</u> to change the length of the online course <u>from</u> two hours <u>to</u> two hours and 15 minutes.

<u>Present law</u> provides that the online handgun education course shall cover all of the following topics:

- (1) Handgun basics and nomenclature.
- (2) Firearm-free zones.
- (3) Use of deadly force.
- (4) Interactions with law enforcement officers.
- (5) Conflict resolution.
- (6) Accident prevention.
- (7) Unauthorized access prevention.
- (8) Safe handling of a handgun.

<u>Proposed law</u> retains <u>present law</u>, but amends the topic of "handgun basics and nomenclature" to include handling procedures for a revolver and a semiautomatic pistol.

<u>Proposed law</u> further combines the topic of "safe storage of firearms" with the topic of "accident prevention".

<u>Proposed law</u> further adds the topic of "suicide prevention, with an emphasis on the impact of firearm-related suicides involving veterans and current service members of the U.S. Armed Forces" to the course.

<u>Present law</u> provides that the DPS&C, office of state police, shall divide the topics provided in <u>present law</u> into eight video segments that shall broadcast for no less than 15 minutes per segment.

<u>Proposed law</u> amends <u>present law</u> to change the number of video segments <u>from</u> eight <u>to</u> nine, but still provides that the video segments shall broadcast for no less than 15 minutes per segment.

(Amends R.S. 14:95(M)(1) and (2) and R.S. 40:1379.3(B)(2)(a), 1379.3.3(B), (D)(1) and (6), and (F)(2); Adds R.S. 14:95(N) and R.S. 40:1379.3(D)(9); Repeals R.S. 14:95(M)(3))

## Summary of Amendments Adopted by House

- The Committee Amendments Proposed by <u>House Committee on Administration of</u> <u>Criminal Justice</u> to the <u>original</u> bill:
- 1. Make technical changes.
- 2. Relative to the exception to the <u>present law</u> crime of illegal carrying of weapons:
  - (a) Expand the exception <u>from</u> any Louisiana resident <u>to</u> any person.
  - (b) Remove certain persons from the exception.
- 3. Increase the length of the online handgun education course offered by state police from two hours to two hours and fifteen minutes.
- 4. Amend <u>present law</u> relative to handgun education course topics.
- 5. Provide for new education course topics.
- 6. Increase the video segments relative to the course topics from 8 to 9.

## The House Floor Amendments to the engrossed bill:

- 1. Make technical changes.
- 2. Provide that any person who meets the qualifications of <u>present law</u> (R.S. 14:95(M)) shall be subject to the same restrictions as a person who carries a concealed firearm pursuant to <u>present law</u> (R.S. 40:1379.3(M) and (N)).
