# PUBLIC HEALTH: Creates a task force to study public health outcomes related to the criminalization of HIV

1	A RESOLUTION
2	To create a task force to study the public health outcomes related to the criminalization of
3	the human immunodeficiency virus (HIV) and to report its findings prior to the
4	convening of the 2024 Regular Session of the Legislature of Louisiana.
5	WHEREAS, HIV represents an ongoing public health concern; and
6	WHEREAS, Louisiana has the fourth highest rate of new HIV diagnoses in the
7	nation; and
8	WHEREAS, the Centers for Disease Control and Prevention has recommended
9	modernization of HIV criminalization laws, stating "many state laws are now outdated and
10	do not reflect our current understanding of HIV"; and
11	WHEREAS, as part of the federal government's Ending the HIV Epidemic initiative,
12	started under President Trump, states are urged to "consider updating or repealing outdated
13	[HIV criminalization] laws and practices"; and
14	WHEREAS, the state of Louisiana launched a state-level initiative similar to the
15	federal government's Ending the HIV Epidemic initiative and has similarly recommended
16	modernization of Louisiana's HIV criminalization law to better serve public interests and
17	public health best practices; and
18	WHEREAS, advancements in clinical research and medical evidence have changed
19	since the inception of HIV criminalization laws, reflecting that HIV cannot be transmitted
20	by casual contact, spitting, or biting; and

1	WHEREAS, advancements in antiretroviral medications, through "treatment as
2	prevention", can reduce HIV to undetectable levels and reduce the risk of transmitting HIV
3	to zero percent while also increasing the life expectancy of affected persons; and
4	WHEREAS, research has shown HIV criminalization laws disincentivize HIV
5	testing, discourage disclosure, and undermine public health goals; and
6	WHEREAS, since 1994, fifteen states have modernized their HIV criminal laws; and
7	WHEREAS, R.S. 14:43.5 provides for the felony crime of intentional exposure to
8	HIV; and
9	WHEREAS, Louisiana is one of thirty-five states with criminal laws specific to HIV
10	and is one of four states that require a person convicted under an HIV-specific law to register
11	as a sex offender; and
12	WHEREAS, in 2018, R.S. 14:43.5 was amended to include affirmative defenses; and
13	WHEREAS, in December 2021, the REPEAL HIV Discrimination Act of 2021 was
14	introduced in the United States House of Representatives with the intent of providing states
15	guidance on reexamining their HIV-specific crime laws and providing incentives for states
16	to explore the repeal or reform of laws and best practices.

3	shall be elected by a majority of the task force members at its first meeting, and the members		
4	may select other officers as the task force deems appropriate.		
5	BE IT FURTHER RESOLVED that the task force shall meet at such times and		
6	places as determined by its chair.		
7	BE IT FURTHER RESOLVED that the members of the task force shall serve		
8	without compensation, except per diem or expenses reimbursement to which they may be		
9	individually entitled to as members or employees of their constituent organizations.		
10	BE IT FURTHER RESOLVED that a majority of the total membership shall		
11	constitute a quorum of the task force, and any official action by the task force shall require		
12	an affirmative vote of a majority of the quorum present and voting.		
13	BE IT FURTHER RESOLVED that the Louisiana Department of Health shall		
14	provide staff support to the task force.		
15	BE IT FURTHER RESOLVED that the task force shall report its findings to the		
16	House of Representatives prior to the convening of the 2024 Regular Session of the		
17	Legislature of Louisiana.		
18	BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to each		
19	of the task force members provided in this Resolution.		
20	BE IT FURTHER RESOLVED that one print copy and one electronic copy of any		
21	report produced pursuant to this Resolution shall be submitted to the David R. Poynter		
22	Legislative Research Library as required by R.S. 24:772.
