24 **Jefferson Davis Parish for tolling activities related to the project described in**
25 **R.S. 48:77(C)(1)(a), and in accordance with applicable state and federal law.**
26 **The Department of Transportation and Development shall, in accordance with**
27 **the Administrative Procedure Act, adopt rules and regulations for the efficient**
28 **implementation and enforcement of the provisions of this Subsection in the**
29 **event a tolling mechanism is established for the project described in R.S.**
30 **48:77(C)(1)(a), and in accordance with applicable state and federal law.**
