3	incurred in the disposition of deceased paupers by the coroners in certain parishes
4	and municipalities.
5	WHEREAS, the Louisiana Municipal Association (LMA) is a statewide member
6	organization that advocates for more than three hundred municipalities and two parishes, and
7	educates and empowers local governments to efficiently and effectively serve the citizens
8	of Louisiana; and
9	WHEREAS, since its inception in 1926, the LMA continues to promote local
10	governments by shaping legislation, providing education on municipal issues, and
11	exchanging ideas and experiences among elected officials throughout the state; and
12	WHEREAS, the LMA provides municipalities with knowledge and assistance on
13	municipal fiscal management; and
14	WHEREAS, municipalities and parishes across the state are responsible for the
15	payment of coroner's services, including the payment of expenses incurred in the disposition
16	of deceased paupers by the coroners; and
17	WHEREAS, some small municipalities are unable to fulfill the obligation for such
18	expenses due to a lack of funding.
19	THEREFORE, BE IT RESOLVED that the House of Representatives of the
