1 AMENDMENT NO. 1

2 On page 1, line 2, change "coverage insurance" to "insurance coverage"

3 AMENDMENT NO. 2

4 On page 1, line 3, delete "shall be covered"

5 AMENDMENT NO. 3

6 On page 1, line 5, after "requirements;" delete the remainder of the line and at the beginning
7 of line 6, delete "health coverage plan;"

8 AMENDMENT NO. 4

9 On page 2, line 1, change "**health plan**" to "**health coverage plan**"

10 AMENDMENT NO. 5

11 On page 2, delete lines 10 through 12 in their entirety and insert in lieu thereof the following:

12 **"(c) National Coverage Determinations of the Centers for Medicare and**
13 **Medicaid Services or Local Coverage Determinations of Medicare**
14 **Administrative Contractors."**

15 AMENDMENT NO. 6

16 On page 2, line 16, change "**processes**" to "**process**"

17 AMENDMENT NO. 7

18 On page 2, line 20, after "**ensure**" delete the remainder of the line and insert in lieu thereof
19 "**that the coverage prescribed in Subsection**"

20 AMENDMENT NO. 8

21 On page 2, delete lines 23 through 29 in their entirety

22 AMENDMENT NO. 9

23 On page 3, delete lines 1 through 3 in their entirety

24 AMENDMENT NO. 10

25 On page 3, at the end of line 9, delete "**is**"

26 AMENDMENT NO. 11

27 On page 3, at the beginning of line 10, delete "**being administered. A biomarker**" and
28 insert in lieu thereof "**currently administered. A "biomarker"**"

1 AMENDMENT NO. 12

2 On page 3, line 13, change "**Biomarker testing**" to "**Biomarker testing**"

3 AMENDMENT NO. 13

4 On page 3, between lines 20 and 21, insert the following:

5 **"(4) "Health coverage plan" means any hospital, health, or medical**
6 **expense insurance policy, hospital or medical service contract, employee welfare**
7 **benefit plan, contract, or other agreement with a health maintenance**
8 **organization or a preferred provider organization, health and accident**
9 **insurance policy, or any other insurance contract of this type in this state,**
10 **including a group insurance plan or self-insurance plan, and the office of group**
11 **benefits. "Health coverage plan" does not include a plan providing coverage for**
12 **excepted benefits defined in R.S. 22:1061, limited benefit health insurance plans,**
13 **or short-term policies that have a term of less than twelve months."**
