A person or entity that 28 directly or indirectly has the right to vote fifty percent or more of the voting interests of an 29 entity or is entitled to fifty percent or more of its profits is presumed to possess a controlling 30 interest."

1 property to a person other than a foreign adversary or a prohibited foreign actor. If the 2 petition or other pleading relates to a property interest vested in a foreign adversary or a 3 prohibited foreign actor, the attorney general may petition the court for an order requiring 4 the proceeds of the sale attributable to the property interest of the foreign adversary or a prohibited foreign actor after the deduction of payments to mortgagees, lienholders, person 5 providing services in connection with the transfer of the property, and credits to the 6 7 purchaser relating to tax and other customary prorations, be deposited in the registry of the 8 court in which the proceeding is pending.

<u>E. No attorney, title insurer, title insurance producer, title insurance agency producer,</u>
 <u>lender, mortgage servicer, notary public, real estate agent, real estate broker, seller, or lessor,</u>
 <u>or any of their directors, officers, or employees shall have a duty to make any investigation</u>
 <u>as to whether a party to a transaction involving immovable property is a foreign adversary</u>
 <u>or prohibited foreign actor, nor shall any such person be liable for failing to identify that a</u>
 <u>party to a transaction involving immovable property is a foreign adversary or prohibited</u>
 <u>foreign actor.</u>

16 <u>F. The provisions of this Section shall apply only to property acquired by a foreign</u> 17 adversary or prohibited foreign actor after August 1, 2023. If a foreign adversary or 18 prohibited foreign actor acquires immovable property despite the prohibitions contained 19 herein, the property shall only be subject to forfeiture during the period in which the foreign 20 adversary or prohibited foreign actor owns the property. Rights in immovable property shall 21 not be void or voidable because the property or right therein previously was held by a 22 foreign adversary or prohibited foreign actor."
