(1) The Department of Justice shall provide the public electronic access to all minute entries as provided in Paragraph (B)(5) of this Section, immediately upon input, through a secured online accessible connection or portal, which shall include the functionality for the user to request electronic notification for any new minute entries for a particular case.

(2) The Department of Justice shall also have the authority to receive from the clerks of court and the clerks of court specified in Paragraphs (B)(1) through (4) of this Section shall have the authority to provide to the Department of Justice, all records and data, on a periodic basis, for the purpose of review, statistical analysis, and to provide reports on relevant information and results from this pilot program to the public and the legislature. The Department of Justice and the clerks of court specified in Paragraphs (B)(1) through (4) of this Section may enter into agreements with each other to define the manner and methods of compliance with this Subsection.

42 (3) The Department of Justice shall review the written request submitted by 43 <u>a clerk of court pursuant to Paragraph (B)(6) of this Section and determine the</u> 44 <u>compatibility of the clerk's system for participation in the pilot program. The</u>
