| 7  | Section 1. R.S. 40:1666.5(A) and (D) are hereby amended and reenacted to read as        |
| 8  | follows:  |
| 9  | §1666.5. Fireman's Supplemental Pay Board   |
| 10 | A. There is hereby created a Fireman's Supplemental Pay Board, hereinafter              |
| 11 | referred to as the board, which shall consist of five seven persons appointed by the    |
| 12 | governor. Each appointment by the governor shall be submitted to the Senate for         |
| 13 | confirmation. In making his appointments the governor shall select two three            |
| 14 | persons who are members in good standing of the Professional Firefighters               |
| 15 | Association of Louisiana, two persons who are members in good standing of the           |
| 16 | Louisiana State Fireman's Association, and one at-large member who has at least         |
| 17 | twenty-five years of firefighter experience. and two persons who are members in         |
| 18 | good standing of the Louisiana Fire Chiefs Association. The board shall elect a         |
| 19 | chairman from its membership to serve a two-year term.                                  |
