Requests certain actions by the Office of Group Benefits relative to pharmacy benefit managers and contracts relative thereto

Proposed resolution directs the Office of Group Benefits (OGB) to request information regarding reimbursements, rates, dispensing fees, pharmacy network participation fees, policies and criteria for designating drugs as specialty drugs, and information regarding policies concerning the use of mail-order pharmacy services from contractors providing pharmacy benefit services. Proposed resolution directs OGB to include provisions prohibiting pharmacy benefit managers from the use of spread pricing and financial clawbacks and provisions requiring data reporting measures in future contracts for pharmacy benefit manager services. Proposed resolution directs OGB to report to the Joint Legislative Committee on the Budget (JLCB) by 11/01/2023.
