17 In Amendment No. 3 by the House Committee on the Administration of Criminal Justice
18 (#3842), on page 1, between lines 28 and 29 insert the following:

21 C. Hallucinogenic substances. Unless specifically excepted or unless listed
22 in another schedule, any material, compound, mixture, or preparation, which
23 contains any quantity of the following hallucinogenic substances, or which contains
24 any of their salts, isomers, or salts of isomers, whenever the existence of such salts,
25 isomers, or salts of isomers is possible within the specific chemical designation, for
26 purposes of this Subsection only, the term "isomer" includes the optical, position,
27 and geometric isomers:

29 (65) Tetrahydrocannabinols, including synthetic equivalents and derivatives,
30 except for tetrahydrocannabinols in hemp and any cannabinoid that is derived or
31 synthesized from hemp and altered by a chemical reaction that changes the molecular
32 structure of any natural cannabinoid derived or synthesized from hemp to another
33 cannabinoid with psychotropic properties including without limitation the following:

- 34 (a) Delta-1 cis or trans tetrahydrocannabinol;
- 35 (b) Delta-6 cis or trans tetrahydrocannabinol;
- 36 (c) Delta 3.4 cis or trans tetrahydrocannabinol;
- 37 (d) Delta 7 tetrahydrocannabinol;

- 1 (e) Delta 8 tetrahydrocannabinol;
- 2 (f) Delta 9 tetrahydrocannabinol;
- 3 (g) Delta 10 tetrahydrocannabinol;
- 4 (h) Hexahydrocannabinol;
- 5 (i) Tetrahydrocannabiphoral;
- 6 (j) Tetrahydrocannabinol acetate;
- 7 (k) Delta-8 tetrahydrocannabinol acetate ester;
- 8 (l) Delta-9 tetrahydrocannabinol acetate ester;
- 9 (m) THC-O; and
- 10 (n) Tetrahydrocannabivarin.
