AN ACT

2	To enact R.S. 36:4(B)(37) and Chapter 3-H of Title 40 of the Louisiana Revised Statutes of
3	1950, to be comprised of R.S. 40:600.151, relative to homelessness; to create the
4	Louisiana Interagency Council on Homelessness within the office of the governor;
5	to provide relative to the membership, governance, and powers and duties of the
6	council; and to provide for related matters.
7	Be it enacted by the Legislature of Louisiana:
8	Section 1. R.S. 36:4(B)(37) is hereby enacted to read as follows:
9	§4. Structure of executive branch of state government

13	(37) Louisiana Interagency Council on Homelessness (R.S. 40:600.151).

15	Section 2. Chapter 3-H of Title 40 of the Louisiana Revised Statutes of 1950,
16	comprised of R.S. 40:600.151, is hereby enacted to read as follows:
17	CHAPTER 3-H. LOUISIANA INTERAGENCY
18	COUNCIL ON HOMELESSNESS
19	§600.151. Louisiana Interagency Council on Homelessness
20	A. There is hereby created, within the office of the governor, the Louisiana
21	Interagency Council on Homelessness, referred to in this Chapter as the "council",
22	for the purpose of developing a statewide plan to end homelessness in Louisiana.
23	B. The term "homelessness" for the purpose of this Chapter shall have the
24	same meaning as provided in the Homeless Emergency Assistance and Rapid
25	Transition to Housing Act of 2009 (42 U.S.C. 11302).

1	C. The duties and responsibilities of the council shall include but are not
2	limited to the following:
3	(1) To develop a statewide plan to end homelessness, which shall include
4	and address the following:
5	(a) Identification and analysis of the particular challenges and barriers that
6	cause people in Louisiana to become at risk of homelessness, to experience
7	homelessness, and to be unable to return to housing.
8	(b) Assessment of factors that contribute to episodes and rates of
9	homelessness at the individual, community, and state levels.
10	(c) Proposed actions and policies to address the challenges, barriers, and
1	factors that contribute to homelessness.
12	(2) To advise the governor, legislature, and local governments as appropriate
13	on the causes of homelessness in Louisiana.
14	(3) To submit an annual written report to the governor and the legislature
15	regarding the statewide plan to end homelessness.
16	D.(1) The membership of the council shall be reflective of all geographic
17	regions of the state and shall be comprised of the following members:
18	(a) The commissioner of administration or his designee.
19	(b) The executive director of the Louisiana Housing Corporation or his
20	designee.
21	(c) The secretary of the Department of Children and Family Services or his
22	designee.
23	(d) The state superintendent of education or his designee.
24	(e) The secretary of the Department of Public Safety and Corrections or his
25	designee.
26	(f) The secretary of the Department of Health or his designee.
27	(g) The secretary of the Department of Veterans Affairs or his designee.
28	(h) One representative from each of the federally recognized continuum of
29	care to end homelessness programs located in Louisiana appointed by the governing
30	board of each continuum of care.

1	(i) The executive director of the Louisiana Services Network Data
2	Consortium or his designee.
3	(j) The executive director of the Louisiana Coalition Against Domestic
4	Violence or his designee.
5	(k) The president of the Louisiana Occupational Therapist Association board
6	of directors or his designee.
7	(1)(i) The chairmen of the Senate and House Committees on Health and
8	Welfare shall appoint six members. Three members shall be appointed by the senate
9	chairman and three members shall be appointed by the house chairman. The
10	members shall be appointed from a list of nominations submitted jointly by the
11	governing boards of the continuums of care located in Louisiana.
12	(ii) Each person appointed pursuant to this Subparagraph shall have at least
13	five years of academic or professional expertise in housing or services for people
14	experiencing homelessness with a focus in one or more of the following areas:
15	(aa) Street outreach.
16	(bb) Diversion, rapid resolution, or homeless prevention services.
17	(cc) Emergency shelter.
18	(dd) Transitional housing.
19	(ee) Rapid re-housing.
20	(ff) Permanent supportive housing.
21	(gg) Behavioral health or substance abuse disorders.
22	(hh) Homelessness as it relates to actual or perceived sexual orientation,
23	gender identity, or marital status.
24	(ii) Racial or ethnic disparities in homelessness.
25	(jj) Veterans homelessness.
26	(kk) Youth homelessness.
27	(ll) Chronic homelessness.
28	(mm) Domestic violence.
29	(m) The executive director of the Louisiana Housing Corporation shall
30	appoint at least two members with lived experience of homelessness. The members

HB NO. 506 **ENROLLED** 1 shall be appointed from a list of nominations submitted jointly by the governing 2 boards of the continuums of care located in Louisiana. Each member appointed 3 pursuant to this Subparagraph shall represent as many of the following 4 subpopulations as possible: 5 (i) Youth aged twenty-four or under. 6 (ii) Veterans. 7 (iii) People experiencing or who experienced chronic homelessness. 8 (iv) People with differing actual or perceived sexual orientation, gender 9 identity, or marital status. 10 (v) Survivors of domestic violence. 11 (2) Appointed members shall serve two-year terms. Members are eligible 12 for reappointment. Any designee shall serve at the pleasure of the designating 13 authority. 14 (3) Members appointed pursuant to Subparagraphs (D)(1)(1) and (m) of this 15 Subsection shall receive a per diem for attendance at council meetings. The per diem 16 shall be paid by the Louisiana Housing Corporation. 17 (4) The council shall elect a chairman and officers from its membership. 18 (5) The council shall meet at regularly scheduled intervals and at the call of 19 the chairman. 20 E. The Louisiana Housing Corporation shall provide support for the council, 21 including staff, facilities, and resources to facilitate remote participation in meetings to the extent authorized by law.
