This Act shall become effective upon signature by the governor or, if not 35 signed by the governor, upon expiration of the time for bills to become law without signature 36 by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If 37 vetoed by the governor and subsequently approved by the legislature, this Act shall become 38 effective on the day following such approval.
