Abstract: Provides for the distribution of surplus monies in the witness fee fund for Pineville City Court.

<u>Present law</u> provides for the collection of court costs, known as "witness fees", to pay offduty law enforcement officers who are required to be present in a criminal case or delinquency proceeding. Provides that each judicial district shall establish a schedule of witness fees and shall place these fees in a special fund administered by the governing authority.

<u>Proposed law</u> provides that in the Pineville City Court, surplus monies in the witness fee fund that exceed \$15,000 at the end of each calendar year shall be transferred to the operating fund of North Rapides Crime Stoppers to be used solely for operational expenses.
