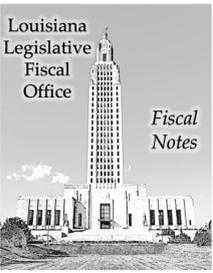

 Provides relative to the requirements for doing business for a motor vehicle service contract provider

Present law provides for application for initial registration and requires each registrant to pay a \$600 application fee to the secretary of state. Proposed law removes the application fee and retains present law regarding the application and initial registration. Present law provides for application renewal requirements. Present law further requires each provider to pay a renewal fee of \$250 to the secretary of state. Proposed law removes the renewal fee and retains present law regarding application renewal.
