I FGISLATIVE FISCAL OFFICE

Provides relative to the penalties for illegal carrying of a firearn at a parade. (8/1/24)

<u>Current law</u> provides that the penalty for committing the crime of illegal carrying of weapons with any firearm used in the commission of a crime of violence within 1,000 feet of any parade or demonstration for which a permit is issued by any governmental entity shall be fined not more than \$2,000, or sentenced to imprisonment for no less than 1 nor more than 5 years, with or without hard labor, or both. <u>Proposed law</u> retains current law and adds that the first year of any sentence of imprisonment shall be without benefit of parole, probation, or suspension of sentence; becomes effective 8/01/24.

## **EXPENDITURE EXPLANATION**

There is no anticipated direct material effect on governmental expenditures as a result of this measure.

For informational purposes, the Department of Public Safety & Corrections - Corrections Services reports that in 2019, there was one (1) admission (no admits in 2020, 2021, 2022, or 2023) with an average sentence length of 1 year for those convicted of illegal carrying of weapons with any firearm used in the commission of a crime of violence within 1,000 feet of any parade or demonstration. Though proposed law mandates that a maximum of one year of the sentence for violation of <u>current law</u> be served without probation, parole, or suspension of sentence, the average sentence imposed for those convicted is one year, which would result in no fiscal impact with the passage of the proposed law.

## **REVENUE EXPLANATION**

There is no anticipated direct material effect on governmental revenues as a result of this measure.
