Proposed law defines "emergency medical personnel" to include Emergency Medical Services (EMS) practitioners and certified ambulance operators. Proposed law clarifies that in addition to the Louisiana Bureau of EMS, the Louisiana EMS Certification Commission shall also have access to criminal records for anyone seeking an EMS practitioner license or ambulance operator certification. Proposed law removes unused EMS exams from the exam fee schedule. Proposed law updates language and reorganizes present law concerning EMS licenses and certifications and the composition of the Louisiana EMS Certification Commission.
