22	§702. Declaration of purpose
23	A. The Legislature of Louisiana does hereby recognize the state's role and
24	responsibilities in ensuring that the net proceeds of charitable games of chance
25 26	conducted pursuant to the Charitable Raffles, Bingo, and Keno, and Box Pools or
20 27	<u>Squares</u> Licensing Law are contributed to bona fide charitable causes. The legislature further finds that it is in the public interest to prevent infiltration of
28	elements of organized crime or professional gambling into charitable gaming.
29	B. Therefore, it shall be the policy of the state of Louisiana to decrease the
30	potential for fraud in charitable games of chance and to increase compliance with the
31	provisions of the Charitable Raffles, Bingo, and Keno, and Box Pools or Squares
32	Licensing Law and other applicable laws and regulations through monitoring and
33	enforcement as well as public education and awareness of the purposes of these laws
34	and regulations.

36	§705. Office functions, duties, and responsibilities
37	The office shall have the following functions, duties, and responsibilities:
38	(1) To issue and renew annual state licenses required by law for
39	organizations conducting games of chance pursuant to the Charitable Raffles, Bingo,
40	and Keno, and Box Pools or Squares Licensing Law, for manufacturers or
