1 AMENDMENT NO. 1

2 On page 1, line 2, after "Procedure" and before the comma "," change "Article 999" to
3 "Articles 999 and 1000"

4 AMENDMENT NO. 2

5 On page 1, line 6, after "Procedure" and before "hereby" change "Article 999 is" to "Articles
6 999 and 1000 are"

7 AMENDMENT NO. 3

8 On page 1, after line 14, add the following:

16 **ORDER OF EXPUNGEMENT UNDER**
17 **CODE OF CRIMINAL PROCEDURE ARTICLE 999**

18 Pursuant to Code of Criminal Procedure Article 999, wherein all of the following applies,

19 (1) The defendant was seventeen years of age when he was arrested or
20 charged with any criminal offense as provided in Title 14 of the Louisiana Revised
21 Statutes of 1950.

22 (2) The district attorney, for any reason, declined to prosecute all offenses
23 arising out of that arrest, including the reason that the person successfully completed
24 a pretrial diversion program,

25 (3) Prosecution was instituted and such proceedings have been finally
26 disposed of by dismissal, sustaining of a motion to quash, or acquittal.

27 **IT IS HEREBY ORDERED, ADJUDGED, AND DECREED** that the following
28 charges and arrest on the dates provided herein be expunged upon the completion of
29 the information below.

30 If there is an objection to the Motion for Expungement, the district attorney
31 and the arresting law enforcement agency shall file a motion to object within
32 sixty days of the service of this Order.

33 If the Louisiana Bureau of Criminal Identification and Information objects
34 to the Motion for Expungement, they shall file a motion within 120 days of
35 the service of this order (prior to August 1, 2015) and within 60 days of
36 service of this order (after August 1, 2015).

37 **NO CONTRADICTORY HEARING SHALL BE REQUIRED** as
38 evidenced by the "Affidavit of No Opposition" executed by each agency
39 named herein and attached to the Motion for Expungement.
