HUNTING: Provides relative to bear hunting

1	AN ACT
2	To amend and reenact R.S. $47:463.45(C)(1)$ and R.S. $56:10(B)(9)$ and $291$ and to enact R.S.
3	56:103(D), 116.3(I), 3002(A)(6), and 3007(H), relative to bear hunting; to provide
4	for the use of funds in the Conservation Fund black bear account; to provide relative
5	to bear hunting licenses; to establish fees for bear hunting licenses; to authorize the
6	Wildlife and Fisheries Commission to create a bear harvest permit lottery; to
7	authorize the secretary of the Department of Wildlife and Fisheries to auction one
8	bear harvest permit; to establish a lottery application fee; to dedicate funds to the
9	black bear account; to allow the feeding of wild bears for purposes of baiting; and
10	to provide for related matters.
11	Be it enacted by the Legislature of Louisiana:
12	Section 1. R.S. $47:463.45(C)(1)$ is hereby amended and reenacted to read as follows:
13	§463.45. Special prestige license plates; Louisiana black bear

15	C.(1) Except as provided in Paragraph (2) of this Subsection, the revenues
16	realized from the additional twenty-six dollar fee imposed by Subsection B of this
17	Section shall be remitted to the state as provided by law. The state treasurer shall
18	place an amount equal to those revenues in the Conservation Fund, after complying
19	with the requirements of R.S. 56:10(B), and shall credit that amount to the "black
20	bear account" which is created within the Conservation Fund through the provisions

22	addition to a basic hunting license, a resident shall be required to purchase and have
23	on his person a black bear hunting license.

25	§116.3. Special provisions applicable to deer and bear; times and methods of taking;

28	I.(1) No person shall hunt or take bear without a bear hunting license and a
29	bear harvest permit. The commission shall promulgate and adopt rules and

1	regulations to establish a lottery for the selection and issuance of bear harvest
2	permits. There shall be a fifty dollar nonrefundable entry fee for bear harvest permit
3	lottery applications. Bear harvest permits and tags may be issued to successful and
4	eligible lottery applicants at no cost.
5	(2) In addition to the lottery provided for in Paragraph (1) of this Subsection,
6	the secretary may provide for the issuance of a single bear harvest permit to be
7	subject to auction by the department, or by an incorporated nonprofit organization
8	dedicated to the conservation of fish and wildlife resources, as determined by the
9	department, which may be sold to the highest eligible bidder.
10	(3) All revenues derived from lottery applications and auction proceeds shall
11	be deposited into the black bear account created within the Conservation Fund
12	through the provisions of R.S. 56:10(B)(9) and be used exclusively for managing,
13	conserving, restoring and enhancing black bear in Louisiana.

15	§291. Feeding of wild bears prohibited
16	No person shall intentionally feed or attempt to feed a wild bear. The
17	provisions of this Section shall not apply to baiting of bears by properly licensed
18	hunters in possession of a bear harvest permit and shall not prohibit legal baiting of
19	deer. The first violation of this Section by any person shall result in the issuance of
20	a warning ticket only. Any subsequent violation by the same person shall be a class
21	two violation. The Wildlife and Fisheries Commission is authorized to promulgate,
22	under the Administrative Procedure Act, rules and regulations for the administration
23	and enforcement of this Section.

Abstract: Authorizes black bear hunting, establishes license requirements, authorizes the Wildlife and Fisheries Commission to establish a lottery, authorizes the secretary of the Department of Wildlife and Fisheries to auction for black bear harvest permits, and allows dedicated black bear funds to be used for management, conservation, restoration, and enhancement of the black bear.

<u>Present law</u> creates a black bear account within the Conservation Fund with a restriction that funds in the account only be used for conserving, restoring, and enhancing black bear habitat.

<u>Proposed law</u> removes the requirement that funds in the black bear account be used solely for habitat and adds a permitted use for managing black bears, so the funds may be spent on managing, conserving, restoring, and enhancing the black bear in the state.

<u>Present law</u> creates a special prestige license plate for the La. black bear and directs that the fees received through the sale of this plate be credited to the black bear account in the Conservation Fund.

<u>Present law</u> further requires that the funds from the license plate can only be used for nongame purposes.

Proposed law removes the restriction on funds being used only for nongame purposes.

<u>Proposed law</u> requires a basic hunting license, a bear hunting license, and a bear harvest permit to hunt and take black bears.

<u>Proposed law</u> authorizes the Wildlife and Fisheries Commission to establish a lottery for bear harvest permits and establishes a \$50 fee for lottery applications.

<u>Proposed law</u> further authorizes the secretary of the Dept. of Wildlife and Fisheries to auction a single bear harvest permit to the highest bidder.

<u>Proposed law</u> requires that all revenue received from the sale of lottery applications and from the auction of bear permits be deposited in the black bear account in the Conservation Fund.

Present law prohibits the feeding of wild bears.

<u>Proposed law</u> provides an exception to this prohibition for baiting of bears by properly licensed and permitted hunters.

Present law establishes fees for recreational hunting licenses and dedicates license revenue.

<u>Proposed law</u> establishes a \$25 fee for resident bear hunting licenses and dedicates the revenue from bear hunting licenses to the black bear account in the Conservation Fund.
