**HOUSE COMMITTEE AMENDMENTS**

2024 Regular Session

Amendments proposed by House Committee on Health and Welfare to Original House Bill No. 711 by Representative Galle

AMENDMENT NO. 1

On page 1, line 12, change "shall have" to "has" and after "as" and before "R.S. 40:1223.3" insert "that term is defined in"

AMENDMENT NO. 2

On page 1, at the end of line 13, delete "at least fifteen years of age"

AMENDMENT NO. 3

On page 1, at the beginning of line 14, delete "but" and after "age" delete the remainder of the line and insert in lieu thereof a period "."

AMENDMENT NO. 4

On page 1, delete line 15 in its entirety

AMENDMENT NO. 5

On page 1, line 17, after "drug," and before "gene" insert "monoclonal antibody" and after "product," and before "DNA-based" delete "or"

AMENDMENT NO. 6

On page 1, line 18, after "product" and before the comma "," delete "into the body"

AMENDMENT NO. 7

On page 2, line 1, change "42 §300aa-10" to "42 §300aa-26"

AMENDMENT NO. 8

On page 2, line 4, after "parent" and before "legal" delete the comma "," and insert in lieu thereof "or" and after "guardian" delete the comma ","

AMENDMENT NO. 9

On page 2, at the beginning of line 5, delete "or representative"

AMENDMENT NO. 10

On page 2, line 6, after "(2)" delete the remainder of the line and delete lines 7 through 18 in their entirety and insert in lieu thereof the following:

"Prior to the administration of any vaccine authorized for emergency use to a minor, healthcare providers shall provide the Fact Sheet for Recipients available from the Centers for Disease Control and Prevention to the parent or legal guardian."

AMENDMENT NO. 11

On page 2, line 19, change "C.(1)" to "C.(1)(a)"

2 On page 2, line 21, after "parent" and before "legal" delete the comma "," and insert in lieu  
3 thereof "or" and after "guardian" and before "of" delete the comma "," and "or representative"

4 AMENDMENT NO. 13

5 On page 2, between lines 22 and 23, insert the following:

6 "(b) Written, informed consent from the parent or legal guardian of the  
7 minor shall be provided to healthcare providers at school-based health centers within  
8 seventy-two hours prior to vaccination. The signed consent form shall be kept in the  
9 student's file for as long as the student is enrolled in the school."

10 AMENDMENT NO. 14

11 On page 2, line 23, after "parent" and before "legal" delete the comma "," and insert in lieu  
12 thereof "or" and after "guardian" and before "shall" delete the comma "," and "or  
13 representative"

14 AMENDMENT NO. 15

15 On page 2, between lines 24 and 25, insert the following:

16 "(3) A parent or legal guardian may dissent from providing immunization  
17 information to public and non-public schools in accordance with R.S. 17:170(E).  
18 D.(1) Notwithstanding any provision of this Section to the contrary, a school  
19 or parish health unit may accept a written informed consent signed elsewhere by the  
20 parent or legal guardian of the minor if the date of signature is not more than three  
21 days prior to the date of vaccination.  
22 (2) As used in this Subsection, the term "school" includes elementary and  
23 secondary schools, kindergartens, colleges, universities, proprietary schools,  
24 vocational schools, and licensed day care centers, whether public, charter, private,  
25 or parochial."

27 On page 2, line 27, change "act" to "acts"

29 On page 3, delete line 1 in its entirety and insert in lieu thereof the following:

30 "refuse to renew the healthcare provider's license or take any other  
31 disciplinary"

33 On page 3, line 7, after "the" and before "shall" delete "department" and insert in lieu thereof  
34 "licensing authority"
