EDUCATION EG NO IMPACT See Note  
Provides relative to student instruction requirements

Proposed legislation requires the Louisiana Department of Education (LDOE) to establish and maintain a list of student instruction required by law that is not provided for in the state content standards adopted by the Board of Elementary and Secondary Education (BESE) or the Carnegie units established by LDOE in accordance with BESE policy. Specifies the content of the list and requires a report to the House and Senate education committees every five years. Provides that any requirement for additional instructional content will become effective only if the requirement is offset by the elimination of another instructional requirement which requires at least the same amount of time as the added requirement.
