HEALTH CARE/FACILITIES: Provides relative to healthcare outcomes for patient's suffering with behavioral health issues

AN ACT

2 To enact R.S. 28:53.1 and R.S. 40:1165.1(A)(5), relative to care for patients with behavioral 3 health issues; to provide for discharge procedures; to provide for communication 4 between healthcare professionals, patients, and patient's family, caregivers, and loved 5 ones; to require the provision of educational documents; and to provide for related 6 matters. 7 Be it enacted by the Legislature of Louisiana: 8 Section 1. R.S. 28:53.1 is hereby enacted to read as follows: 9 §53.1. Healthcare provider notification requirements 10 If a patient is confined for inpatient behavioral healthcare services pursuant 11 to an emergency certificate issued in accordance with R.S. 28:53, the healthcare 12 professional with the authority to discharge the patient and the healthcare facility 13 housing the patient during confinement shall make a reasonable effort to do all of the 14 following: 15 (1) Notify any healthcare professional providing behavioral health services 16 to the patient prior to confinement of the date and time the patient is scheduled to be 17 discharged. The notification required by this Paragraph shall be in writing and occur 18 at least twenty-four hours before the patient is discharged. 19 (2) Notify any third-party healthcare professional that the patient is 20 scheduled to visit for follow-up behavioral health services within twenty-four hours

**Abstract:** Establishes procedures for healthcare professionals providing care for patients suffering from behavioral health issues.

<u>Proposed law</u> states that if patient confined to inpatient behavioral healthcare services as a result of an emergency certificate issued by a physician, the inpatient healthcare facility shall make a reasonable effort to do all of the following:

- (1) Notify any healthcare professional treating the patient by providing behavioral healthcare services that the patient is to be discharged. The notice shall be transmitted to the appropriate individuals at least 24 hours prior to discharge.
- (2) Notify any healthcare professional scheduled to provide follow-up behavioral healthcare services of the patients discharge 24 hours prior to discharge. The notice shall include of a summary of the patient's condition and any medically relevant information.
- (3) Provide the patient educational documents prior to discharge explaining the signs of self-harm and the importance of seeking follow-up care.

<u>Proposed law</u> requires a healthcare professional that offers behavioral health services to accept documents from the family, friends, loved ones, and caregivers of the patient about the patient related to the patient's behavioral health issues.
