CONSUMERS: Prohibits government restriction of choice regarding vehicles

AN ACT

2 To enact R.S. 39:364.1, relative to combustion engine vehicles; to provide for freedom of 3 choice for private individuals in the selection of vehicles; to specify that air quality 4 challenges cannot restrict a citizen's ability to purchase a vehicle; and to provide for 5 related matters. 6 Be it enacted by the Legislature of Louisiana: 7 Section 1. R.S. 39:364.1 is hereby enacted to read as follows: 8 §364.1. Preservation of choice in vehicle purchases; combustion engine vehicles 9 A. For purposes of this Section, "combustion engine vehicle" shall mean the 10 component of a motor vehicle that converts the chemical energy in fuel into 11 mechanical energy for power. 12 B. No state agency shall restrict the use or sale of a motor vehicle by any 13 citizen based on the energy source used to power the motor vehicle, including the 14 energy source used for propulsion or use of powering other functions of the motor 15 vehicle. 16 C. No state agency shall limit or prohibit the use or sale of a new motor 17 vehicle with an internal combustion engine. Further, any air quality challenges in 18 R.S. 30:2060(L), relative to "Louisiana's Toxic Air Pollutant Emission Control 19 Program" shall not restrict the ability of Louisiana citizens to purchase any vehicle.

**Abstract:** Prohibits government restriction of freedom of choice regarding the purchase of any vehicle by a private citizen.

<u>Proposed law</u> defines a "combustion engine vehicle" as the component of a motor vehicle that converts the chemical energy in fuel into mechanical energy for power.

<u>Proposed law</u> prohibits state agencies from restricting the use or sale of a motor vehicle based on the energy source used to power the motor vehicle, inclusive of the energy source used for propulsion or use of powering other functions of the motor vehicle.

<u>Proposed law</u> prohibits a state agency from limiting or prohibiting the sale or use of new motor vehicles with internal combustion engines.

<u>Proposed law</u> specifies that any air quality challenges related to the La. Air Pollutant Emission Control Program cannot restrict a La. citizen's ability to purchase any vehicle.
