2 To commend the Gulf State Renewable Energy Industries Association (GSREIA) and to
3 designate Tuesday, April 2, 2024, as Gulf State Renewable Energy Industries
4 Association Day at the capitol.

5 WHEREAS, Gulf State Renewable Energy Industries Association (GSREIA) is a
6 trade association of member companies leading the renewable energy industry; and

7 WHEREAS, the renewable energy sector includes a diverse array of companies
8 throughout the supply chain, including manufacturers, suppliers, distributors, and developers
9 of energy systems and components, as well as providers of installation, maintenance, and
10 grid integration services; and

11 WHEREAS, GSREIA is at the forefront of advocacy and education for the renewable
12 energy industry, and has fostered expansion of the renewable energy sector in terms of utility
13 scale, commercial and residential energy generation and storage; these efforts create jobs and
14 save taxpayer money; and

15 WHEREAS, GSREIA promotes the expansion of solar energy generation in terms
16 of growing the renewable energy sector as a whole, and the association has strengthened our
17 region's renewable energy infrastructure by considerable measures; these efforts have also
